The meeting was called to order at 9:30 a.m. by Vice Chairman Larry Thompson with a quorum present.

Secretary Bergquist informed the Commission that the meetings are now being live streamed by South Dakota Public Broadcasting.

Secretary Bergquist requested to take the agenda items out of order and move the election of officers to the end of the agenda, which would be followed by an executive session pursuant to SDCL 1-25-2(3). There being no objections, the chair allowed the change in the order of agenda items.

Vice Chairman Thompson asked for a motion to approve the minutes of December 20, 2016.

A MOTION WAS MADE by Roby to approve and seconded by Vanneman. All present voted aye by roll call vote. The motion carried.

Vice Chairman Thompson opened the floor to Commission members to disclose potential conflicts of interest and to present requests for waivers pursuant to South Dakota Codified Law (SDCL) chapter 3-23.

There were no disclosures or waivers to address.

\*\*\*\*\*

A public hearing was conducted to consider adopting an amendment to administrative rule 70:01:02:00 concerning speed zone rules on Interstate Highways. No written comments were received. No members of the public offered testimony in support of or in opposition to the proposed rule change.

A MOTION WAS MADE by Roby to adopt the amendment to administrative rule 70:01:02:00 concerning interstate highway speed zones. The motion was seconded by Rosenboom. All present voted aye by roll call vote. The motion carried.

A public hearing was conducted to consider adopting an amendment to administrative rule 70:01:02:60 - Tripp County Speed Zone Rule. Todd Hauf, the mayor of the City of Colome, submitted a written comment in favor of the rule amendment. This comment

was read into the record. No other written comments were received. No members of the public offered testimony in support of or in opposition to the proposed rule change.

A MOTION WAS MADE by Fouberg to adopt the amendment to administrative rule 70:01:02:60 concerning speed zone limits in Tripp County. The motion was seconded by Vanneman. All present voted aye by roll call vote. The motion carried.

**RESOLUTION #2017-01.01 was adopted.**

\*\*\*\*\*

Secretary Bergquist reported the Department has completed its statutorily required briefing to the Legislative House and Senate Transportation Committees. We have also completed our budget hearing to the Joint Appropriations committee. Our budget remains unchanged with the exception of one item. We have requested a reduction of 12 full-time equivalent (FTE) positions and the associated personnel services dollars that go along with those FTEs. The Department will not be changing the level of staffing; the FTE reduction reflects underutilized FTEs.

The Department has filed two bills. SB22 deals with drones and exempts certain unmanned aircraft systems from the requirement to be registered. This has been through the Senate Transportation Committee and full senate and received no dissenting votes. SB23 revises the authority of the Transportation Commission to make loans from the state highway fund to local governments for highway and bridge construction and maintenance purposes. The intent of this bill is to make clear in state law that the commission has the authority to make state highway funded loans and receive repayment on those loans. SB23 has passed the Senate Local Government with one dissenting vote and has passed the Senate floor with one dissenting vote.

The Department is supporting a couple of bills that the Department of Public Safety has brought on our behalf dealing with overweight and oversized vehicles. There was a bill introduced in the Senate that would change snow plow responsibilities for towns with populations under 2,500. This bill could have an adverse budgetary impact to the Department if passed.

Last year a bill was defeated that would prohibit the use of any federal funds for the printing and distribution of state maps. This same bill has been introduced again this year. We opposed this bill last year and we will oppose it again this year.

Dick Howard with the Association of Towns & Townships presented a funding package for small structures and culverts on local roads. Proponents of the proposed funding package were Dirk Rogers, Tom Tveit, Greg Vavra, and David Scott. Opponents to the

proposed funding package were Representative Mary Duvall, Deb Mortenson, Brenda Forman, Yvonne Taylor, and David Owen.

A MOTION WAS MADE by Roby to reject the proposed funding package that would require the use of state highway funding for small structures and culverts on local Township roads. The motion was seconded by White. All present voted aye by roll call vote. The motion carried.

Jason Humphrey, Construction Engineer, Division of Operations, presented the following information regarding Construction Change Orders to the Transportation Commission:

Construction change orders approved in December contain a decrease of approximately \$17,196.

Over the past 12 months, the overall contract increase is 1.31%.

This CCO brings the items to their final measured quantities and final compensations. The slip ramps were inadvertently missed in the plans and necessary for providing access to Murdo during construction. The reconstruction of the ramps is in preparation for use on a 2017 project on the adjacent lanes.
