After analysis of the bids received for Bid #'s 4 and 6 and discussion with potential bidders, the bid price is considered to be high for the work being completed. The possibilities for re-letting the projects have some potential to improve pricing. As a

result, the Department of Transportation recommended rejection of the contracts for Bid #'s 4 and 6.

A MOTION WAS MADE to reject Bid #6 by Seljeskog and seconded by Roby. All voted aye and motion carried.
