Chairman Glodt brought the commission out of executive session at approximately 11:38 a.m. CT.

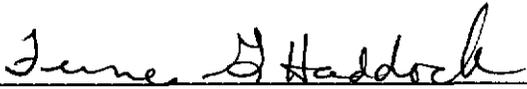
PAPSC 2015-11
