Secretary Bergquist requested that the Transportation Commission propose a hearing date to consider amendment or repeal of rules found in chapters 70:01:02, 70:07:01, 70:07:02, and 70:07:03 of the Administrative Rules of South Dakota.

The proposed rule changes concern speed zones and contractor bidding capacity requirements for highway construction contracts.

**17-078** This revision adjusted the cost estimate of a combined lighting & curb upgrade project on US12 in Lemmon, and shoulder widening and AC surfacing projects on US12 from the ND state line to Lemmon and on SD73 from north of the Grand River to US12 at Lemmon (Item #737, Page 154 of the 2017 2020 STIP Book).

**17-079** This Sioux Falls Area wide pipe work project (which was added in June) was changed from federal and state funding to 100 percent state funding.

Mike Behm presented for the Right of Way office and provided the following items for Commission consideration:

1. Transfer – Lawrence County

Request Transportation Commission approval to transfer by resolution to the City of Deadwood the following property acquired for highway right-of-way:

Lot A1 in a portion of Lot H2 and the 66 foot right of way of US Highway 85 in Tract 1 of the Jim Lode Mineral Survey 1636; the 66 foot right of way of US Highway 85 in Lot 7 and Placer Claim 57 in Section 27 - Township 5 North - Range 3 East of the B.H.M., and a portion of Lot H2 and the 66 foot right of way of US Highway 85 in M.S. 107 in Section 27 - Township 5 North – Range 3 East of the B.H.M., all located in the City of Deadwood, Lawrence County, South Dakota, containing 44,162 square feet, more or less, according to the plat thereof to be filed for record in the office of the Register of Deeds in and for said county.

The above transfer completes Agreement Number 614300 signed by the City of Deadwood on July 7, 2014, and signed by the State of South Dakota Department of Transportation on August 5, 2014; and the actual transfer of title to the City of Deadwood pursuant to said agreement not having yet been made of all the state of South Dakota's interests in real property, including without

limitation, roadways, bridges, culverts, sidewalks, right-of-way fences, and all other fixtures and appurtenances.

The highway right-of-way described above would be transferred to the City of Deadwood and the City of Deadwood would accept ownership, jurisdiction and maintenance responsibilities of the above described right-of-way. (See Attached plat)

A MOTION WAS MADE by Roby to approve item #1 and seconded by Vanneman. All present voted aye by voice vote. The motion carried.

Said Lot AB1 contains 284 sq. ft. or 0.01 acre.

Lot AB2 in the US Highway 85 right-of-way in M.S. 107, lying adjacent to Lot C of M.S. 107 in the City of Deadwood, Lawrence County, South Dakota.

Said Lot AB2 contains 1,062 sq. ft. or 0.02 acre.

Lot AB3 in the US Highway 85 right-of-way in M.S. 107, lying adjacent to Lot A of M.S. 107 to the City of Deadwood, Lawrence County, South Dakota.

Said Lot AB3 contains 3,046 sq. ft. or 0.07 acre.

Lot AB4 in the US Highway 85 right-of-way in M.S. 107, lying adjacent to Lot PL, of M.S. 107 to the City of Deadwood, Lawrence County, South Dakota.

Said Lot AB4 contains 5,111 sq. ft. or 0.12 acre.

Said Lot AB1 contains 721 sq. ft. or 0.02 acre.

Lot AB1 in a portion of the 66 foot right-of-way of US Highway 85 in Placer Claim 57 in Section 27 – Township 5 North – Range 3 East of B.H.M., City of Deadwood, Lawrence County, South Dakota.

Said Lot AB1 contains 859 sq. ft. or 0.02 acre.

Lot AB1 in a portion of the 66 foot right-of-way of US Highway 85 in Placer Claim 58 in Section 27 – Township 5 North – Range 3 East of B.H.M., City of Deadwood, Lawrence County, South Dakota.

Said Lot AB1 contains 339 sq. ft. or 0.01 acre.

Lot AB1 in the US Highway 85 right-of-way in the SE1/4 of Section 27 – Township 5 North – Range 3 East of B.H.M., lying adjacent to Deadwood Gulch's of Fun Tract 2, Lawrence County, South Dakota.

Said Lot AB1 contains 2,470 sq. ft. or 0.06 acre.

The above abandonment lots are located along US 85 in Deadwood.

DOT project NH-PH 0085(20)26, PCN 0555 has been completed and the above property is no longer needed for highway purposes. Abandonment is recommended by DOT Rapid City Region and Area. (See attached plats)

A MOTION WAS MADE by Fouberg to approve item #2 and seconded by Marquardt. All present voted aye by voice vote. The motion carried.

3. Request for Utility Easement – Butte County

Request Transportation Commission approval to grant an overhead powerline permanent easement to Black Hills Power, Inc. of Rapid City, SD upon the following DOT property:

Lot A in the Southwest Quarter Southwest Quarter (SW1/4SW1/4) of Section 15, Township 8 North, Range 2 East of the B.H.M., Butte County, South Dakota.

Lot A is located on the south side of Hwy 34 in Belle Fourche and serves as the DOT maintenance shop site facility. Granting the 20-foot wide easement as shown on Exhibit "A" allows BHP to provide service to a new DOT truck storage building.

Black Hills Power accepts financial responsibility for the overhead powerline. All State and Federal guidelines will be followed during the construction. (See attached Exhibit A)

A MOTION WAS MADE by Vehle to approve item #3 and seconded by Roby. All present voted aye by voice vote, with the exception of White who abstained. The motion carried.

4. Abandonment – Pennington County

This resolution will abandon the temporary easement on Pennington County Project

5. Abandonment – Minnehaha County

This resolution will abandon the temporary easement on Minnehaha County Project IM 29-3(68)80, PCN 1177.

A MOTION WAS MADE by Vehle to approve items #4 and #5 and seconded by Marquardt. All present voted aye by voice vote. The motion carried.

## RESOLUTIONS #2017-09.04 and #2017-09.05 were adopted.
