Chairman White called the meeting of the Transportation Commission (the "Commission") to order at 9:00 a.m. Roll call was taken and a quorum was determined.

Chairman White opened the floor to Commission members to disclose potential conflicts of interest and to present requests for waivers pursuant to South Dakota Codified Law (SDCL) chapter 3-23.

No conflicts of interest were disclosed and no waivers were requested.

Chairman White asked for a motion to approve the minutes of March 1, 2018.

A MOTION WAS MADE by Roby and seconded by Fouberg to approve the March 1, 2018, meeting minutes. All present voted aye by roll call vote. The motion carried.

Chairman White asked for a motion to approve the minutes of March 15, 2018.

A MOTION WAS MADE by Vehle and seconded by Roby to approve the March 15, 2018, meeting minutes. All present voted aye by roll call vote. The motion carried.

Karla Engle of the Office of Legal Counsel requested that the Transportation Commission consider approval of amendments to the following speed zone rules:

- 70:01:02:02 Pennington County speed zone
- 70:01:02:09 Lawrence County speed zone
- 70:01:02:12 Bon Homme County speed zone
- 70:01:02:32 Hamlin County speed zone
- 70:01:02:38 Hyde County speed zone
- 70:01:02:48 Marshall County speed zone
- 70:01:02:49 Meade County speed zone
- 70:01:02:51 Miner County speed zone
- 70:01:02:53 Perkins County speed zone
- 70:01:02:55 Roberts County speed zone

Engle explained the procedural steps that were followed concerning the above set of rules. The Department of Transportation (the "Department") is asking the Commission to do one of two things: for five of the nine rules, the Department is asking the Commission to revise the existing rule to reduce the limited speed zone to match the signage that is currently in place on the highways.

These rules include:

- 70:01:02:02 Pennington County speed zone rule change on US Highway 16 in Rapid City.
- 70:01:02:09 Lawrence County speed zone rule change on US Highway 385 southeast of Deadwood. The Department received a written comment from Mayor Chuck Turbiville of Deadwood regarding this rule change. The written comment was provided to the Commissioners and to the public. Mayor Turbiville commented that he didn't have any objection to the speed zone change proposed but took the opportunity to ask for other changes that will be addressed in the May Commission meeting.
- 70:01:02:12 Bon Homme County speed zone rule change on SD Highway 50 in and around Avon. The Department received one written comment for this rule change submitted by Mr. Frank Kloucek. The written comment was distributed to the Commission members at the meeting and emailed to those on the teleconference call. Engle summarized the comment for Commissioners. Kloucek written comment was in regard to requested speed zone rule changes to be made by Tyndall and Tabor and not to this current speed zone rule change on SD Highway 50 in and around Avon.
- 70:01:02:32 Hamlin County speed zone rule change on SD Highway 28 near Lake Poinsett.
- 70:01:02:53 Perkins County speed zone rule repeal on SD Highway 20 near the village of Prairie City.

The second category of rules to be considered is where the Department is asking the Commission to revise the speed zones to be somewhat different than what is currently signed. These rules are:

- 70:01:02:38 Hyde County speed rule changes on SD Highway 47 in Highmore.
- 70:01:02:48 Marshall County speed rule change on SD Highway 10 in Britton.
- 70:01:02:49 Meade County speed rule change on Interstate Highway 90 Frontage Road in Blackhawk
- 70:01:02:55 Roberts County speed rule change on SD Highway 23 at Wilmot

The final rule to be considered was submitted the "conventional way". The Department analyzed the highway in response local government concerns and determined that a speed zone change should be initiated. This rule is as follows:

 70:01:02:51 Miner County speed rule change on State Trunk Highway 34 from the west side of Howard

Written comment received from Deadwood Mayor Chuck Turbiville were provided to the commission in its meeting packet and brought to the attention of the commission by Engle. Engle also distributed to the commission copies of a series of e-mails received from Frank Kloucek relating to the proposed rules. Copies of these e-mails were also made available to members of the public attending the meeting. No members of the public appeared to offer testimony in support of or in opposition to the rule changes.

A MOTION WAS MADE by Marquardt and seconded by Rosenboom to approve all rules considered. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2018-03.03 was adopted.

Engle requested that the Transportation Commission propose a hearing date to consider changes to 70:01:02:12 -- Bon Homme County speed zone rule. 70:01:02:12 of the Administrative Rules of South Dakota.

A MOTION WAS MADE by Marquardt and seconded by Roby to set the administrative hearing date for the April 26, 2018, Commission meeting. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2018-03.04 was adopted.

Secretary Darin Bergquist presented two items as part of the Secretary's Report. Bergquist provided a summary of the recently completed legislative session including a discussion on the electric hybrids and the variable speed limit changes. Bergquist said the Department's budget passed as proposed.

With the Chair's, permission, Bergquist requested that the agenda item entitled "Consideration of Special Provision for Price Schedule for Miscellaneous Items" be removed from the agenda.

Bergquist also provided an update on the appropriations bill that Congress passed which includes highway funding for this year. An additional \$2.5 billion dollars was budgeted for other programs and \$14 million dollars in extra federal highway funds for the Department. The bill also includes an expansion of existing grant programs, including the TIGER grant program.

Greg Fuller, Division Director of the Division of Operations, presented the following information regarding Construction Change Orders to the Transportation Commission:

Construction change orders approved in February contain an increase of approximately \$1,392,688.

Over the past 12 months, the overall contract increase is 2.34%.

The following projects have a Construction Change Order (CCO) amounting to a contract change in excess of \$50,000.

Explanation of Change on CCO No. 1: This decrease is the result of the Department adjusting the contract quantities to match the quantity used during construction. The larger decreases include asphalt emulsion for micro surfacing, pavement marking paint, flagging, and pilot car. The decreases are the result of normal variations and are common for this work.

Explanation of Change on CCO No. 1: This decrease is the result of the Department adjusting the contract quantities of flagging and pilot car to match the quantity used during construction. The Contractor's operation was more efficient than estimated resulting in the need for less hours of flagging. The Contractor was able to use flaggers equipped with radios accommodate traffic eliminating the need for a pilot car.

V. Project: IM-PH 0291(122)0, Lincoln County, PCN 02PT Location: I-29 Structures near Sioux City Contractor: PCI Roads, LLC Type of Work: Bridge Rehabilitation

Explanation of Change on CCO No. 4: This increase is the result of the Contractor performing additional concrete removal and patching. During construction, the Department identified additional delaminated concrete on the bridge deck in need of repair. When traffic is removed from the roadway, the Department is able to perform a closer inspection of the site and more accurately determine the extent of the necessary repair areas. This variation is common for the work.

Explanation of Change on CCO No. 6: This increase is the result of the Department adjusting the contract quantities to match the quantity used during construction. The larger increases include Contractor furnished borrow, seeding, mulching, fertilizer, gravel cushion, furnish concrete overlay, asphalt binder, and asphalt concrete. The Contractor used the additional Contractor furnished borrow to flatten the slopes along the project to the required 6:1 slope and to flatten the slopes at the Exit 191 ramps. The increase to the

slops flattening work also resulted in the need for additional seeding, mulching, and fertilizer to reseed the disturbed areas. The Contractor used additional gravel cushion due to the Contractor's sequence and the availability of salvage material on the project. The Department approved concrete surface profile resulted in additional furnish concrete overlay than estimated in the plans. The Contractor paved additional asphalt concrete on the shoulders, ramps at Exit 191, and the weigh scale site. This additional work also resulted in the need for additional asphalt binder.
