Chairman Rosenboom called the meeting to order at 9:32 a.m. Roll call was taken and a quorum was determined.

Chairman Rosenboom asked for a motion to approve the minutes of March 23, 2017.

A MOTION WAS MADE by Roby to approve and seconded by Fouberg. All present voted age by roll call vote. The motion carried.

Chairman Rosenboom asked for a motion to approve the minutes of April 13, 2017.

A MOTION WAS MADE by Roby to approve and seconded by Vanneman. All present voted aye by roll call vote. The motion carried.

Chairman Rosenboom opened the floor to Commission members to disclose potential conflicts of interest and to present requests for waivers pursuant to South Dakota Codified Law (SDCL) chapter 3-23.

Commissioner Roby disclosed a potential conflict of interest regarding the Bridge Improvement Grants awards as he serves on the city commission in Watertown. Karla Engle, Office of Legal Counsel, stated that his service on the city commission did not fall within the parameters of the conflicts of interest law, SDCL 31-23-1, *et seq.* Roby stated that he would still like to abstain from voting.

Karla Engle of the Office of Legal Counsel asked the Commission to set a public hearing for May 25, 2017 to consider proposed amendments to the following speed zone rules:

A MOTION WAS MADE by White to set the hearing date as requested and seconded by Vanneman. All present voted aye by roll call vote. The motion carried.

Resolution #2017-04.01 was adopted.

Secretary Bergquist asked the Commission to amend the agenda to enter into executive session immediately after the conclusion of regular business.

Bergquist began his report by informing the Commission of the passing of Dick Gregerson, former Transportation Commission member. Gregerson had served on the Commission with distinction for 16 years.

Bergquist and the Commission congratulated Commissioner Fouberg on being presented with the Governor's Excellence in Economic Development Award by Governor Daugaard at the annual Governor's Office of Economic Development (GOED) Conference in Sioux Falls.

Bergquist announced that Commissioners Roby and Fouberg were re-appointed by the Governor and that Commissioner Kathy Zander would return for the May meeting. Bergquist stated the Commission only needed to fill one vacancy.

Bergquist asked if Wayne Lloyd was present. Becky Hedman of the AGC said that he was delayed. It was decided by the Commission to proceed with Lloyd's testimony

upon his arrival and the Commission proceeded with the regularly scheduled agenda items.

Greg Fuller, Director of the Division of Operations, presented the following information regarding Construction Change Orders to the Transportation Commission: Construction change orders approved in March contain an increase of approximately \$467,725.

Over the past 12 months, the overall contract increase is 1.77%.

The following projects have a Construction Change Order (CCO) amounting to a contract change in excess of \$50,000.

<u>Explanation of Change on CCO No. 1F:</u> This increase was the result of additional asphalt concrete crack sealant material used during construction of the project. The Department identified additional cracks in need of sealing resulting in the increase in quantity.

II. Project: NH 0013(34), Beadle County, PCN 053E

Location: Various Routes in Huron Area

Contractor: Bituminous Paving Inc.

Type of Work: Asphalt Surface Treatment (Chip Seal)

Original Contract Amount: \$ 841,438.14 Change on CCO No. 2F: \$ 86,475.33 Net Change to Date: \$ 86,475.33

<u>Explanation of Change on CCO No. 2F:</u> This increase was the result of additional asphalt for surface treatment, cover aggregate, asphalt for fog seal, and pavement markings required upon construction. The change in quantities was the result of the Department deciding to place an asphalt surface treatment on the entire roadway width including the shoulders. This change increased the

quantity necessary for construction. Additionally, the Department made a fuel cost adjustment in accordance with the contract.

Doug Kinniburgh, Local Governments Engineering Manager discussed the applications that were received for the Bridge Improvement Grant program and provided the Commission with the scores that the department assigned to each application. He also provided the department's recommendations for approval. The recommended grant funding includes 17 bridge preservation projects totaling \$2.681 million, seven bridge replacement/rehabilitation projects totaling \$4.705 million and 29 preliminary engineering grants totaling \$0.872 million. The balance to bring the total funding up to \$9 million will be used for Construction Engineering costs.

Grant funds are limited to a maximum of \$4 million per entity over a three year period to ensure the funds are shared among as many local governments as possible. The local governments are required to pay a minimum of 20 percent matching funds and have three years to expend the grant.

One hundred and ten applications totaling \$20.55 million were received by the South Dakota Department of Transportation (SDDOT). Nine cities submitted 11 applications and 39 counties submitted a total of 99 applications.
