#### SUBJECT: Consideration of Industrial Park Grant application

The Department of Transportation has received an Industrial Park Grant request from the City of Elk Point for consideration by the Transportation Commission at their June 29 meeting. The city is requesting \$300,000 in grant funds for the construction of Moss Street in their Industrial Park. This will serve the expanding BalCon Enterprises. The capital investment for the facility is \$1.8 million. The company will employ 20 full time employees.

The Governor's Office of Economic Development has reviewed the grant application and recommends award.

### PROJECT LOCATION:

Southwest Quarter of the Northeast Quarter of Section 24, Township 91 North, Range 50, West of the 5<sup>th</sup> P.M., City of Elk Point, less, Lot H-1 and less that part lying West of Interstate Highway I-29, Union County, South Dakota, and Donnelly Tract 5 in the Northeast Quarter of the Northeast Quarter of Section 24, Township 91 North, Range 50, West of the 5<sup>th</sup> P.M., City of Elk Point, Union County, South Dakota.

### **PROJECT DESCRIPTION:**

In 2011, the City of Elk Point purchased 26 acres of agricultural land, for \$210,000. The City used this land to create a new industrial park. The City also paid \$196,000 for a new crushed concrete road leading to the industrial park, along with necessary drainage and a retention pond. The industrial park has been split into seven lots. BalCon Enterprises wants to expand its business, and it is interested in building in the new Elk Point Industrial Park. The City of Elk Point needs to build an access road through the industrial park, to accommodate the incoming businesses. This access road will be 1,875 feet long, with an 80 foot right-of-way, and will be constructed of eight inches of PCC pavement, over six inches of base course, over 10 inches of recompacted existing subgrade.

# INDUSTRIAL PARK AND AGRI-BUSINESS ACCESS GRANTS

1. BUSINESSES TO BE SERVED AND PROPOSED EXPANSION PLAN: BalCon Enterprises, headquartered in Elk Point, South Dakota, has been in business since 2003, and has warehousing/processing locations near Pittsburgh, Pennsylvania; Dallas, Texas; Chicago, Illinois; and Burbank, South Dakota. BalCon is an industrial packaging company that specializes in selling Gaylord boxes and FIBC bulk bags. Through recycling processes, BalCon is able to refurbish several thousands of tons of Gaylord boxes each year and recirculate them to companies throughout the United States and Canada. BalCon also recycles corrugated material used to make paperboard and FIBC bulk bags used to make many plastic parts in the United States.

BalCon will construct a new 20,000 square-foot warehousing/processing center in the City of Elk Point's Industrial Park in the spring of 2017. The current leased facility in Burbank, South Dakota, will be maintained. The expansion is estimated to cost \$880,000 (\$690,000 for the building, \$130,000 for the equipment, and \$60,000 for the land). BalCon estimates that up to 20 additional full-time employees will be needed for this facility over the next three years.
