Chairman Odenbach called the meeting of the South Dakota Aeronautics Commission meeting to order at 1:00 p.m. Roll call was taken and a quorum was determined.

Chairman Odenbach opened the floor to Commission members to disclose potential conflicts of interest and to present requests for waivers pursuant to South Dakota Codified Law (SDCL) chapter 3-23.

Funk stated that he would have a conflict of interest regarding the Brookings agenda item, due to a lease he has with the Brookings airport. This conflict of interest has been previously disclosed and voted upon by the Aeronautics Commission as fair, reasonable, and not contrary to the public interest.

Chairman Odenbach asked for a motion to approve the minutes of May 23, 2017.

A MOTION WAS MADE by Lantis and seconded by Luers to approve the May 23, 2017, meeting minutes. All present voted aye by roll call vote. The motion carried.

The Commission discussed ideas regarding how the Commission will deal with future requests regarding airport fuel systems. The Commission has reviewed the previously requested airport revenue information from the Department of Transportation staff. This will be an ongoing discussion at Commission meetings.

Commissioner Lantis notified the Commission that the Bison airport had an insufficient amount of aircraft fuel. Lantis was contacted by a pilot with this complaint.

A MOTION WAS MADE by Luers and seconded by Lantis to instruct the DOT staff to notify the Bison airport of the complaint and recommend the airport follow the FAA fuel system maintenance circular along with any applicable DOT rules. All present voted aye by roll call vote. The motion carried.

The Lake Cochrane Improvement Association is requesting Commission approval for a State airport license to operate the Lake Cochrane seaplane base as a public use seaplane base. An on-site seaplane base evaluation was accomplished on April 28, 2017 by the FAA Rapid City Flight Standards District Office and it was determined safe operations can be conducted at the proposed site. The seaplane base is to be operated during the daylight hours and for VFR use only.

Program Manager, Jack Dokken presented the Commission with three documents supporting the approval of a seaplane base: (1) a letter of approval and support was submitted by the Lake Cochrane Improvement Association, which clarified James Ekholm’s authority to request and sign the seaplane base application on behalf of the association; (2) a letter from the South Dakota Department of Game, Fish and Parks supporting the seaplane base application; and (3), a letter from the FAA approving the seaplane base application.

A MOTION WAS MADE by Vanderhule and seconded by Luers to approve a State airport license to operate the Lake Cochrane seaplane base as a public use seaplane base. All present voted aye by roll call vote. The motion carried.

Program Manager, Jack Dokken presented the Commission with a request to purchase pre-loaded flash drives to promote aviation education.
