1. Call to Order and Roll Call - President K Possehl called the meeting to order at 9:00 a.m. on April 20, 2017.

2. Board of Nursing Minutes

Board Action: D Bergeleen moved to approve the February 16-17, 2017 Board Meeting minutes, seconded by S Neuharth.

The minutes were approved in a unanimous voice vote.

Board Action: D Letcher moved to approve the March 16, 2017 Board Meeting minutes, seconded by M Schmidt. The minutes were approved in a unanimous voice vote.

3. Agenda Approval

Board Action: N Nelson moved to approve the agenda, seconded by D Letcher. The agenda was approved in a unanimous voice vote.

4. Financial Reports - G Damgaard presented the Financial Report for Fiscal Year 2017 (July through March).

Board Action: N Nelson moved that the South Dakota Board of Nursing accept the financial report as presented, seconded by S Neuharth. The Financial Report for Fiscal Year 2017 July through March was approved in a unanimous voice vote.

5. Reports

A) Licensure and Operations Report - E Matthies presented the April 2017 South Dakota Board of Nursing’s licensure and operations report. As of April 2017 there were 21,878 licensed LPNs, RNs, and APRNs; and 16,217 actively registered Certified Nurse Aides (CNA), Dialysis Technicians (UDT), Medication Aides (UMA, and Diabetes Aides UDA).

B) External Meeting Reports

- **Collaborating for the future of Regulation** – G Damgaard reviewed the National Council State Boards of Nursing’s (NCSBN) proposed model rules for simulation.
- **Next Generation NCLEX Project** – G Damgaard presented the Project Summary on NCSBN’s Next Generation National Council Licensure Examination (NCLEX). The NCSBN NCLEX Committee and staff conducted research to examine how the NCLEX exam needed to change to meet future entry level competence needs for new graduates to continue to assure safe nursing practice in the evolving practice environment of the future. Results of their research identified a need for the NCLEX RN examination to include measuring a graduate’s ability to use clinical judgment. As a result of the findings, a next generation of NCLEX is in development.
- **Expanded Membership Rights and Responsibility** - G Damgaard reviewed the NCSBN document.

- **Standards Committee** - L Young provided a report. In 2013 NCSBN received designation to be an American National Standards Institute (ANSI) accredited standards developer organization. NCSBN formed a committee to develop standards and guide the approval process of nursing regulatory standards. Since 2013 the following three standards are approved by ANSI as national standards: Criminal Background Checks for Licensure as a Nurse; Reporting of Disciplinary Actions by Boards of Nursing; and Primary Source Verification of Licensure by Endorsement.

6. **Open Forum** - K Possehl, President, provided the opportunity for guests to address the Board, no one requested to do so.

7. **Environmental Scan** – Documents were provided for informational purposes, including the current issue of the *Journal of Nursing Regulation* (2017), 8 (1).

8. Unfinished Business

A) **eNLC Update** – G Damgaard reported that so far 19 states have enacted the new Enhanced Nurse Licensure Compact (eNLC); South Dakota was the first state to enact the legislation. This new eNLC is a multi-state nurse licensure compact that will replace the current compact that South Dakota and 24 other states use. The new eNLC will become effective on Dec. 31, 2018 or when 26 states enact the compact. The actual implementation of the new compact will occur six months after the effective date. G Damgaard also reported she is meeting every 2 weeks with the states that have enacted the compact to discuss implementation issues.
