Iran Scrutinized Companies List

The Iran divestment law (SDCL 4-5-48 to 4-5-60) went into effect on July 1, 2010. The Council utilizes two public lists, Colorado and Florida, to determine the South Dakota list of Iran scrutinized companies. The Colorado list is generally used with select additions from the Florida list.

Colorado's recently updated the list on January 19,2018 and Florida on March 7, 2018.

The Council passed motions in April and June of 2012 to keep three companies not on the Colorado list on the South Dakota list until removed from the Florida list. The three companies are Sinopec, CNOOC Ltd. and China Oilfield Services Ltd. These companies remain on the March 7, 2018 Florida list and therefore will continue to be included on the South Dakota list.

Florida added to their list three Sinopec subsidiaries: Sinopec Group Overseas Development 2012 Ltd, Sinopec Group Overseas Development 2014 Ltd and Sinopec Oilfield Equipment Corp. and three China National Petroleum Corporation (CNPC) subsidiaries: Bank of Kunlun Co Ltd, China Petroleum Engineering Corp and Kunlun Financial Leasing Co Ltd.

Gazprom OAO and Gazprom Neft were removed from the Colorado lists but remain on the Florida list. Removal of these companies from the South Dakota list is not recommended at this time pending further evaluation of the reasons for removal of the companies by Colorado and the continued inclusion by Florida.

The law allows SDRS to invest indirectly in companies on the list through pooled funds. SDRS has about 0.5% of total fund assets invested in a pooled fund managed by Dimensional Fund Advisors (DFA) which at times has held companies on the list. DFA has been informed of the law and their response is on file. SDRS is less than 1% of the DFA pooled fund.

Staff continues to monitor changes to the Federal sanctions law, or its application, to determine the effect on the South Dakota Iran scrutinized companies list.

STAFF RECOMMENDATION: Staff recommends adding the three Sinopec subsidiaries and the three China National Petroleum Corp subsidiaries to the South Dakota Iran scrutinized companies list at the April 19, 2018 Council meeting.
