# Panel Priorities: Parental Awareness of Rights and Procedural Safeguards

Discussed the Indicator 8: Parental Survey report results

- Recommend special education staff use the same verbiage in survey so it is familiar to the families as fill out the survey.
- Recommendation is develop a script for new teachers.
- Students, who are placed out of district, communicate with agency/placement on who is doing the survey.

Betsy Schwenk reviewed with the group the priority recommendations from September 2017 meeting. There was additional discussion on each recommendations brought forward from September.

#### 1. Local level

- a. Parent advisory boards within districts
  - i. Topics- procedural safeguards, organizations that offer support, transition, etc.
- b. Parent information booths in the resource room
  - i. Inform parents at conferences that booths are available in the resource room with information about topics that pertain to them

#### 2. University Level

a. In-service training to include Mock IEP with SD Parent Involvement Survey while using the language of the survey questions

# 3. State Level

- a. South Dakota Parental Rights and Procedural Safeguards
  - Create and provide access to tutorials
    - Tutorials to include video with practice quiz. The quiz should give instant feedback to your answer. If you answer correctly the automated quiz should give you a positive response. If you answer incorrectly the quiz should respond with a negative response and the correct answer immediately. This is meant for education purposes.
  - ii. Podcast or web video to explain procedural safeguards and to explain outside organizations
- b. Host a parent involvement panel at the SD State Special Education Conference
- c. Create an APP to include the following:

- i. Agency information
- ii. Parental rights
- d. Parent Involvement Online Survey
  - i. Allow for districts to fill out questions #1, #2, #3, #4 and #7
  - ii. Make a drop down box for question #7
  - iii. Integrate the survey into the IEP process

## Rural America Initiatives - Anne Reddy Presenting

Anne discussed the Rural America Initiatives and her work with families. She identified some biggest challenges and supports:

- When a parent first child enters education system and special education the education language is overwhelming. They support them through the language.
- o Some parents are concerned with the special education label.
- o Most parents will accept the services for their child.
- o Transient nature of the families makes it difficult to keep communication connection.
- o Help family make connections and learn about resources in town.
- o Back to School family night is helpful. It is a time to create connections between school and families.

# DOE Update - Presented by Linda Turner

Discussed staff changes, ESSA Plan approval, state testing will start in March, and Special Education Programs will go over IDEA Budget Application and Indicator 17 – State Systemic Improvement Plan at April's Panel meeting.

Senate Bill 46, requiring school districts to adopt a policy limiting the use of restraint and seclusion, was provided to the panel. Panel members had discussion. Panel determined no official panel action will be taken. If individual members would like to testify on the bill, they can do so.
