AGENDA ITEMS:

<u>Director's Report</u>: Director Clark reported on parole hearing numbers, extended detainment, and parole violations and non -compliance numbers. The transition of hearings from SDSP 3rd floor to the JPA visit room, which began in March, 2018 continues to go well and we plan to continue to hold full board sessions in Jameson and make adjustments as necessary to improve operations as we continue this transition. Director Clark asked the Board for input and discussion regarding information included/available for the Board to review as part of the commutation process, specifically the initial, paper review. The Board members were open to requesting and receiving "any requested record, fact or opinion in the Warden's possession or knowledge" as required in SD statute, as part of the review process. Board staff will continue to work with the Warden to ensure that this information is made part of the commutation process. Board Member Schroyer made a motion that board office staff notify the warden of the respective institution of upcoming two-panel commutation hearings, requesting input, recommendations or opinions on the offender and the merit of the request. Board Member Hajek seconded the motion. All members voting aye, the motion carried.

The NIC Orientation for Parole Board Members training in Aurora, CO was pushed back from July to August. This date will no longer work for our staff to attend. The office received 11 pardon applications in May. We are now scheduling 2-3 months out for a hearing in front of the Parole Board. Training was

provided to the new case managers, Brandon LaBrie and Jordan Wilcox. Board staff met with the institution staff to review hearing schedules, operations and expectations as a means to improve operations and coverage during board week.

<u>Director of Field Services Report</u>: Brad Lewandowski was available and updated the board on Parole population numbers, workload percentages, community booking closures and average case load numbers. He reviewed the current tribal projects, staffing vacancies, coverage plans and trends we are seeing regarding continuing shifts in supervision levels. Regarding Interstate Compact cases/caseloads, South Dakota remains 100% compliant in all areas since April, 2018. We had one interstate compact parolee returned to South Dakota in the last month for technical violations. DCA, Sarah Ball attended the Midwest DCA meeting in May, 2018 which largely focused on training for the upcoming Annual Business meeting in Florida which will be held in October. The South Dakota State Council for Interstate Compact for Adult Offender Supervision met on 5/22/2018. Doug Barthel was welcomed to the council and was appointed Chairperson. Topics discussed included, audit results, enhancements to the ICOS (data tracking) system and the role of the State Council.

<u>Legal Issues Review:</u> Ashley McDonald updated the board on the ongoing court proceedings related to a Supreme Court decision in a case the Board had previously discussed.

Behavioral Health Review: Tonya Honomichl was available but had no updates for the board.

Policy Review:

8.1. A.10 – Commutations will be reviewed and approved in July 2018.

Board Training and COMS Updates: Traci Fredrikson spoke with the Board about proposed training in the near future. Board Member, Riter – Osborn was approved to attend NIC - New Board Member training in Colorado. Board Members Hajek, Riter - Osborn and Bock have applied to go to Colorado and attend NIC in July 2018; however, the dates have changed from July 2018 to August 2018 and caused a problem for South Dakota staff to attend, so plans for 2019 are underway. California, Arizona and Washington are on the docket to attend our August, 2018 hearings. We are planning on extending parole week in September, 2018 in order to provide training hours as required to the board. The agenda is being worked on, but includes updates from CBH, date calculation information, gender responsivity and SAVIN.

<u>Decisions</u>: Board Member Bock made a motion to ratify and affirm all decisions; Board Member Krull seconded the motion. All members voting aye; the motion carried.
