AGENDA ITEMS:

<u>Director's Report</u>: Director Clark reported on parole hearing numbers and non -compliance numbers that we are seeing each month. Mr. Clark spoke about changes that are happening within parole and the institution and how hearings are going to be prepared for. Transitional Case managers will be making some changes in their job description and duties. Tim Gross, West River Supervisor is celebrating 30 years of service. The Pardon applications are beginning to be done on line and this process seems to being going well. Our contested case hearing numbers are starting to rise. Warrants that are being issued are up. We are going to make some policy changes in the near future on who and what we classify as an absconder. Mr. Clark will send the board via email some of these proposed changes in the next few weeks.

<u>Director of Field Services Report</u>: Brad Lewandowski updated the board on agents who have been out for various situations. Parole Agent Hower is leaving parole. Parole Agent, Adrian Gray Buffalo, is doing an outstanding job with the tribal program. Watertown caseloads are down so we were able to move an agent to work out of the Brookings field office one day a week. Parole Agent Aileen Winters is doing a great job working with the CTP program out of Sioux Falls.

<u>Legal Issues Review</u>: Ashley McDonald addressed an appeal that is in progress in regards to a parole date calculation. Ashley also addressed the board about consecutive sentences and paroling people to their new number.

<u>Behavioral Health Review:</u> Tonya Honomichl appeared on behalf of behavioral health. Tonya updated us on several cases that discharged their sentences or have been released back to the community.

<u>Policy Review:</u> Code of ethics, news media and cameras and evidence based practice policies were sent home with the board members to read and will be approved in February, 2017.

<u>Board Training and COMS Updates</u>: Traci Fredrikson spoke with the Board about some training that will be coming up. We will begin to assign a board member to a pardon applicant each month so that each applicant can be reviewed in greater detail prior to the hearings. There is a training session being set up for March, 2017

<u>Review of Full Board Appearances for February</u>: Board members reviewed a number of parole applicants who have been recommended for a personal appearance before the full board in February, 2017 or later.

<u>Decisions</u>: Board Member Holloway made motion to ratify and affirm all decisions; Board Member Rau seconded the motion. All members voting aye; the motion carried.
