## AGENDA ITEMS:

Director's Report: Director Clark reported on parole hearing numbers and non -compliance numbers. Director Clark reported that without the state of South Dakota implementing the Earned Discharge Program we would have an extra 276 inmates on Parole at this time. The Pardon information requested the previous month was made available and Director Clark reported that extended detainment information was not available in September as a result of some temporary issues with the database used to track them. Work continues with the structured decision making framework (SDMF) with 100% of the parole hearings now using the process. Rex Squyres, Program assistant who works out of Mike Durfee State Penitentiary, has seen a significant change in his duties as he now is responsible for entering in the criminal history portion for all inmates who are going up for Parole in the current month as well as the future. Utah Parole Board Members have requested South Dakota's assistance in helping them with the implementation of the SDMF. Business cards have been ordered and delivered to three of our board members who requested them. We have bought and supplied each board member their own body alarm that they will need to carry with them while inside security perimeters at each facility. Auxiliary members continue to assist with conducting hearings each month we are in need. Savannah Murray is continuing her fall internship and is doing great. We received 12 Pardon applications in August and are now scheduling 2-3 months out. We are beginning to see the effects of the online Pardon application process and we have seen very few errors. We are continuing to move forward in our progression toward being able to notify other agencies through email. We are looking to expand and rebuild our current system that we use for Pardons and processing these applications. A budgetary request was added to the FY 2019 budget for this project. Director Clark has staff working on updating the language in Board policy regarding the criteria to identify full board cases with the hope of providing additional clarity of the process to expanded staff now conducting this work. The suggested edits will be sent out to Board Members in advance of October hearings to allow for discussion and further action. Mike Vonsik, Corrections Specialist celebrated 34 years with the State in August. Stacy Cole, Senior Secretary, South Dakota Board of Pardons and Paroles celebrated 3 years with the State in August.

<u>Director of Field Services Report</u>: Brad Lewandowski was available and updated the board on parole population numbers, community booking closures and the average caseload size per agent. Agents Korth and Schlosser are in phase 3 of training. Agents McQuistion and Beyl are in phase 2 of training. Yankton JCA agents are assisting with the collateral contacts around the state with CTP parolees. We have offered the open SWO agent position to Blake Lohr. We have one open agent position in Rapid City. We have an EBP Senior position open as Dusti Werner has left parole. The workload study reports in COMS have been updates to reflect "agents utilized" and "agents authorized". A total of 8 offenders meeting the standards for compliant discharge now in statue were discharged in August 2017.

Legal Issues Review: Ashley McDonald was unavailable. Catherine Schlimgen was available for any questions and had no updates for the board.

Behavioral Health Review: Tonya Honomichl and Kayla LaBrie were unavailable.

<u>Policy Review:</u> 8.1.A.2 – Parole and Suspended Sentence Revocation Hearings. 8.1. A.13 – Rescission of Parole were sent home with the board to review and approve in October.

<u>Board Training and COMS Updates</u>: Traci Fredrikson reminded the board that we are going to do some training in October 2017. Dusti Werner, Risk Reduction Manager will be speaking to the board in October. This was our first month using the new board sheet and it went well.

<u>Review of Full Board Appearances for October</u>: Board members reviewed a number of parole applicants who have been recommended for a personal appearance before the full board in October 2017 or later.

<u>Decisions</u>: Board Member Riter Osborn made motion to ratify and affirm all decisions; Board Member Schroyer seconded the motion. All members voting aye; the motion carried.
