<u>CALL TO ORDER</u>: The meeting was called to order by Chairman Rex Hagg. He appointed Dennis Landguth as secretary pro tem. The secretary called the roll and Chairman Hagg declared that a quorum was present.

<u>BOARD MEMBERS PRESENT</u>: Rex Hagg, Dennis Landguth, Doyle Karpen, Daryl Englund, Pete Bullene, and Bob Morris.

BOARD MEMBER ABSENT: Gregg Greenfield, Glenn Blumhardt and Linda Hilde.

<u>APPROVAL OF MINUTES FROM NOVEMBER 17, 2016, MEETING</u>: Motion by Karpen, seconded by Landguth, to approve the minutes from the November 17, 2016, Board of Minerals and Environment meeting. A roll call vote was taken, and the motion carried unanimously.

MINING ISSUES

<u>Consent Calendar</u>: Prior to the meeting, the board received a table listing the department recommendations for transfers of liability and release of liability (see attachment).

Tom Cline, DENR Minerals and Mining Program, answered questions from the board regarding the Weatherton Contracting Co., Inc. transfer of liability and release of liability.

Motion by Englund, seconded by Morris, to accept the department recommendations for transfers of liability and release of liability listed on the consent calendar. A roll call vote was taken, and the motion carried unanimously.

SAND, GRAVEL, AND CONSTRUCTION AGGREGATE MINING GENERAL

<u>INFORMATION</u>: Mike Erickson, DENR Minerals and Mining Program, provided a PowerPoint presentation on general information about sand, gravel, and construction aggregate mining in South Dakota. Mr. Erickson answered questions from the board.

CONTESTED CASE HEARING IN THE MATTER OF THE PETITION FILED BY DENR FOR FORFEITURE OF WESTERN SURETY COMPANY (CNA SURETY) BOND NO. 141551847 ISSUED FOR STATE MINE LICENSE 88-364 FOR WEATHERTON CONTRACTING CO., INC.: Chairman Hagg opened the hearing.

Rich Williams, Deputy Attorney General, appeared on behalf of the Department of Environment and Natural Resources.

No one appeared on behalf of Weatherton Contracting Co., Inc.

Tom Cline, DENR Minerals and Mining Program, was administered the oath by the court reporter and testified regarding the surety forfeiture.

Mr. Cline stated that Mine License 88-364 was issued to Weatherton Contracting Co., Inc. on April 11, 1988. Weatherton Contracting Co., Inc. was issued Surety Bond No. 141551847 in the amount of \$20,000 by Western Surety Company, Minneapolis, MN, for statewide mining activities. Weatherton Contracting Co., Inc. conducted mining operations at 66 sites in 19 counties within the state of South Dakota.

In 2007, DENR conducted inspections of the sites licensed under Mine License 88-364 and indicated that approximately 413 acres were not reclaimed at that time. To date, some of those sites have been reclaimed and have been released of liability.

In March and April 2010, the Department of Environment and Natural Resources sent letters to Weatherton Contracting, Co., Inc. indicating that the company had not submitted annual reports and fees as required by SDCL 45-6.

On May 20, 2010, Chris Nelson, Secretary of State, issued a Certificate of Administrative Dissolution of Weatherton Contracting Co. Inc., for failure to file the annual report when due.

The Department of Environment and Natural Resources issued a Notice of Violation to Weatherton Contracting Co. Inc., on August 31, 2010. The company did not respond to the Notice of Violation, therefore, Mine License No. 88-364 was revoked on October 13, 2010.

Weatherton Contracting Co., Inc. has not conducted mining activities at these locations since 2010. Under their revocation, 26 sites remain unreclaimed. Forty sites have been released of liability and are now inactive.

Mr. Cline provided a PowerPoint presentation showing photographs of six mine sites, which total 200 unreclaimed acres. He answered questions from the board.

The exhibits were accepted into the record.

Following Mr. Cline's presentation, Chairman Hagg made a verbal ruling that based on the petition for forfeiture of surety and that there was no response made by Weatherton Contracting Co., Inc., they defaulted in regard to the petition. Chairman Hagg further ruled that based on the evidence presented, the Western Surety bond in the amount of \$20,000 would be forfeited and the proceeds transferred to the Department of Environment and Natural Resources for performance of reclamation activities to the extent feasible.

Motion by Morris, seconded by Karpen to affirm Chairman Hagg's verbal ruling and to adopt the Findings of Fact, Conclusions of Law, and Order in the matter of forfeiture of Western Surety Company (CNA Surety) Bond No. 141551847 issued to Weatherton Contracting Co., Inc. for State Mine License 88-364 declaring the surety forfeited and transferring the \$20,000 to the Department of Environment and Natural Resources, Mined Land Reclamation Fund. A roll call vote was taken, and the motion carried unanimously.

Chairman Hagg declared the hearing closed.

CONTESTED CASE HEARING IN THE MATTER OF THE PETITION FILED BY DENR FOR FORFEITURE OF CERTIFICATES OF DEPOSIT NOS. 65314 AND 85362, FIRST NATIONAL BANK, PIERRE, SD, ISSUED FOR STATE MINE LICENSE 93-507 FOR JAMES P. WENANDE TRUCKING: Chairman Hagg opened the hearing. Rich Williams, Deputy Attorney General, appeared on behalf of the Department of Environment and Natural Resources.

No one appeared on behalf of James P. Wenande Trucking.

Mr. Williams noted that he spoke by phone with Gina Schutzle, First National Bank, and she verbally indicated that the bank would not contest the forfeiture and would not be doing the reclamation.

Tom Cline, DENR Minerals and Mining Program, was administered the oath by the court reporter earlier in the day. He testified regarding the surety forfeiture for James P. Wenande Trucking.

Chairman Hagg stated that the board would take judicial notice of Mr. Cline's testimony in the previous matter and accept that testimony to the extent relevant to this matter.

Mr. Cline testified that Mine License 93-507 was issued to James P. Wenande Trucking on December 1, 1993. The department received no response to the Notice of Violation and Petition for Forfeiture of Surety. Mine License 93-507 was revoked November 23, 2015.

Mr. Cline presented a PowerPoint presentation and stated that mining was last conducted at Site 507001 in 2006. He showed photos of the site which is approximately 1.7 acres. Mr. Cline stated that there is approximately 400 feet of linear high wall that is 10 to 15 feet high which needs to be regraded. The topsoil pile would also need to be spread and revegetated. The cost of reclamation is estimated at \$3,000 to \$5,000 per acre; however, additional costs would be involved in the reclaiming of the high walls.

Mr. Cline answered questions from the board.

Board discussion took place regarding collecting the accrued interest on the forfeited CD.

Mr. Williams stated that SDCL 45-6-71 sets the surety amount at \$500 per affected acre or \$20,000 statewide. Mr. Williams noted that there may be other avenues to collect the additional monies, but for today's purposes, the department was only requesting the stated surety amount.

Mr. Williams offered DENR Exhibit 1, a copy of the agency file for James P. Wenande Trucking, and Exhibit 2, a copy of Mr. Cline's PowerPoint presentation.

The exhibits were accepted into the record.

Following Mr. Cline's presentation, Chairman Hagg made a verbal ruling that based on the petition for forfeiture of surety and that there was no response made by James P. Wenande Trucking, they defaulted in regard to the petition. Chairman Hagg further ruled that based on the evidence presented , the two Certificates of Deposit totaling \$1,000 issued by First National Bank, would be forfeited and the proceeds transferred to the Department of Environment and Natural Resources for performance of reclamation activities to the extent feasible.

Motion by Englund, seconded by Landguth to affirm Chairman Hagg's verbal ruling, and to adopt the Findings of Fact, Conclusions of Law, and Order in the matter of forfeiture of First National Bank Certificates of Deposit Nos. 65314 in the amount of \$500.00 and \$5362 in the amount of \$500 for State Mine License 93-507 for James P. Wenande Trucking, declaring the surety forfeited and transferring the \$1,000 to the Department of Environment and Natural Resources, Mined Land Reclamation Fund.

Mr. Morris suggested that the Findings of Fact, Conclusions of Law, and Order be amended to collect the principal amount plus accrued interest to date for forfeited Certificates of Deposit, if legally possible. He stated that when the operator makes the decision to submit a Certificate of Deposit as surety, the Certificate of Deposit grows according to the terms of the Certificate of Deposit. Mr. Morris said he believes when the Certificate of Deposit is forfeited, it should include all accrued interest, which would help with the ultimate reclamation of the site and minimize the cost to the state.

Mr. Williams stated that SDCL 45-6-71 speaks to revocation of the surety amount only. It does not take into account whether the surety is a certificate of deposit, surety bond, or cash.

Chairman Hagg stated that the last sentence in SDCL 34A-10-2.2 states that interest earned on any bond or deposit made under § 34A-10-2.1 shall be returned annually to the person required to provide the bond.

Charles McGuigan, Chief Deputy Attorney General, stated that the board does not have the authority to take any interest that may have been earned absent a prior agreement. On occasion the board has, as a condition of the financial assurance, stated that any interest earned would be rolled over into the principal amount. That is done by a separate agreement or is specifically stated within

the Order establishing the financial assurance amount. Absent that type of agreement, the board does not have the authority or ability to capture the earned interest.

Mr. Morris stated that he would withdraw his suggestion. He called for the question.

A roll call vote was taken, and the motion carried unanimously.

Chairman Hagg closed the hearing.

CONTESTED CASE HEARING IN THE MATTER OF THE PETITION FILED BY DENR FOR FORFEITURE OF CERTIFICATES OF DEPOSIT NOS. 3761 AND 4403, FIRST INTERSTATE BANK, BELLE FOURCHE, SD, ISSUED FOR STATE MINE LICENSE 86-339 FOR DAKOTA SAND AND GRAVEL, INC.: Chairman Hagg opened the hearing.

Rich Williams, Deputy Attorney General, appeared on behalf of the Department of Environment and Natural Resources.

No one appeared on behalf of Dakota Sand and Gravel, Inc.

Bob Morris stated that he was willing to recuse himself from participating in the matter because the branch manager of First Interstate Bank, Belle Fourche, SD, is the husband of his paralegal.

Responding to a question from Chairman Hagg, Mr. Williams stated that Mike Tyndall, manager of First Interstate Bank (formerly known as First Western Bank), submitted a letter to the Attorney General's Office stating that the bank would not contest the surety forfeiture.

Chairman Hagg stated that since there was no objection to the surety forfeiture, he did not see the need for Mr. Morris to recuse himself.

Tom Cline, DENR Minerals and Mining Program, was administered the oath by the court reporter earlier in the day. He testified regarding the surety forfeiture.

Chairman Hagg stated that the board would take judicial notice of Mr. Cline's testimony in the previous matters and accept that testimony to the extent relevant to this matter.

Mr. Cline stated that Mine License 86-339 was issued to Dakota Sand and Gravel, Inc. on December 29, 1986. The department received no response to the Notice of Violation and Petition for Forfeiture of Surety.

Mr. Cline presented a PowerPoint presentation and stated that mining was last conducted in four different locations, three in Butte County and one in Lawrence County. Three of the four sites have been released from liability by the Board of Minerals and Environment.

Mr. Cline stated that Site 339003 had not been released from liability. Mining was last conducted at this site in 2010. Mr. Cline noted that the mine license was revoked on January 28, 2016.

Mr. Cline showed photos of Site 339003, which is approximately 1.9 acres. Approximately 500 linear feet of high wall that is five to eight feet high remains to be regraded and have the topsoil pile spread and revegetated. Mr. Cline reiterated the reclamation costs of \$3,000 to \$5,000 per acre, with additional costs involved for reclamation of high walls.

Mr. Williams offered DENR Exhibit 1, a copy of the agency file for Dakota Sand and Gravel, and Exhibit 2, a copy of Mr. Cline's PowerPoint presentation.

The exhibits were accepted into the record.

Mr. Cline answered questions from the board.

Chairman Hagg noted that the exhibits show that the total amount of the Certificates of Deposit exceeded \$1,000.

Mr. Williams stated that the amount in excess of \$1,000 reflects the accrued interest, which will go back to the estate of Mr. Falzerano.

Chairman Hagg stated that the Certificates of Deposit were held jointly in the names of Dakota Sand and Gravel, Inc. and the Department of Environment and Natural Resources. He stated that one of the certificates included a note that there was a joint survivor interest, so the question of whether the state is entitled to the accrued interest is revisited. Chairman Hagg said he wondered if there was consent by the estate to pay that as opposed to making an additional claim for reclamation funds. He asked whether that would take a separate action?

Mr. Williams stated that it would take a separate action based on the statutes that were cited during the previous hearing.

Chairman Hagg asked if Dakota Sand and Gravel was still a viable corporation?

Mr. Williams answered that the department's file did not contain a Certificate of Dissolution for Dakota Sand and Gravel, Inc.

Chairman Hagg said an inquiry should be made as to whether any interest on the Certificates of Deposit would be conceded and paid voluntarily to help with the cost of the reclamation.

Following Mr. Cline's presentation, Chairman Hagg made a verbal ruling that based on the petition for forfeiture of surety and that there was no response made by Dakota Sand and Gravel, Inc., they defaulted in regard to the petition. Chairman Hagg further ruled that based on the evidence presented, the two Certificates of Deposit totaling \$1,000 issued by First Interstate Bank, would be forfeited and the proceeds transferred to the Department of Environment and Natural Resources for performance of reclamation activities to the extent feasible.

Motion by Karpen, seconded by Bullene, to affirm Chairman Hagg's verbal ruling and to adopt the Findings of Fact, Conclusions of Law, and Order in the matter of forfeiture of First Interstate Bank Certificates of Deposit Nos. 3761 in the amount of \$500.00 and 4403 in the amount of \$500 for State Mine License 86-339 for Dakota Sand and Gravel, Inc., declaring the surety forfeited and transferring the \$1,000 to the Department of Environment and Natural Resources, Mined Land Reclamation Fund. A roll call vote was taken, and the motion carried unanimously.

Chairman Hagg closed the hearing.

<u>UPDATE ON POWERTECH (USA), INC. APPLICATION FOR LARGE SCALE MINE PERMIT</u> <u>NO. 480 (DEWEY-BURDOCK PROJECT):</u> Chairman Hagg stated this matter was essentially placed on hold by the Board of Minerals and Environment until the federal government acts in their various capacities to make determinations. It was determined by the board chair at that time, that the state couldn't fully fulfill its obligation without knowing the determination of some of the federal issues.

Charles McGuigan, Chief Deputy Attorney General, reported that in November 2013 the Board of Minerals and Environment issued a stay for the matter pending Powertech's applications for a source and byproduct material license from the United States Nuclear Regulatory Commission and also an aquifer exemption and underground injection control Class III and Class V permit from the United States Environmental Protection Agency.

The Nuclear Regulatory Commission has held some hearings on the source and byproduct material license. On December 23, 2016, the Nuclear Regulatory Commission issued an opinion, which dismissed five of the seven contentions that were pending before the commission. There are still two contentions pending before the Nuclear Regulatory Commission. One deals with consultation with the tribes and the survey that was conducted for cultural and historical resources within the property boundaries. The other contention deals with the boreholes that exist in the area and how they will be remediated.

The Environmental Protection Agency hasn't taken any action regarding the aquifer exemption and underground injection control permit. In addition, the Board of Minerals and Environment also conditioned the stay on action by the Water Management Board. The Water Management Board has not held any further hearings on this matter.

<u>CONTESTED ENFORCEMENT HEARING IN THE MATTER OF QUARTZ OPERATIONS,</u> <u>LLC, NORTHERN POINTS 1 WELL; DENR PETITION TO REVOKE PERMIT AND</u> <u>PETITION TO FORFEIT SURETY (O&G PERMIT NO. 2026):</u> A court reporter was present for this hearing and a transcript was prepared. A copy of the transcript may be obtained by contacting Cheri Wittler, Precision Reporting, PO Box 232, Onida, South Dakota 57564, telephone number: 605-258-2678.

The original transcript is filed at the Department of Environment and Natural Resources office in Pierre, SD. Please refer to the transcript for the proceedings of this hearing.

Hearing Chairman Bob Morris opened the hearing.

In October 2016, the Department of Environment and Natural Resources, Minerals and Mining Program, petitioned the Board of Minerals and Environment for a contested enforcement hearing regarding the potential revocation of Quartz Operations, LLC's permit to drill at the Northern Points 1 well site (O&G Permit No. 2026), and potential forfeiture of surety associated with Permit No. 2026. The petition was filed pursuant to SDCL 1-26, SDCL 45-9, ARSD 74:09, and ARSD 74:12.

Steve Blair, Assistant Attorney General, appeared on behalf of the Department of Environment and Natural Resources.

Lance Shurtleff, attorney from Laramie, WY, and Mark Eske, attorney from Sioux Falls, SD, appeared on behalf of Quartz Operations, LLC.

Hearing Chair Morris noted that Charles "Tom" Patterson, attorney from Custer, SD was present in the audience. Mr. Patterson represented Woodford Construction Co., Inc. in the matter of Quartz Operations, LLC surety bond: 2015 partial disbursement request (O&G 2-2015). Chairman Hagg was the hearing chair for that matter, and based upon the Findings of Fact and Conclusions of Law, Chairman Hagg Ordered the following:

- 1. DENR's Motion of Judgement as a matter of law is granted;
- 2. Woodford's Petition Initiating a Contested Case is dismissed without prejudice; and
- 3. The Petition of Richard Davis, allowed by intervention, is also dismissed without prejudice.

Hearing Chair Morris stated that today the Board of Minerals and Environment received a Notice of Levy in Hughes County Small Claims concerning Woodford Construction Co. Inc., Charles Patterson, attorney, versus Quartz Operations, LLC. Hearing Chair Morris acknowledged for the record receipt and service of that Notice of Levy.

Mr. Patterson stated that he was present at the November 2016 Board of Minerals and Environment meeting in Pierre because he thought there was going to be a hearing, but that hearing was continued to today. Mr. Patterson said he had been apprised by DENR's counsel, Steve Blair, that a Motion for Intervention would not be allowed because of the nature of this hearing, and because of the position that Mr. Blair had taken, Mr. Patterson said he had not sought to intervene in the proceedings, but that he was present to hear the evidence. Mr. Patterson said any objections that he might have to the proceedings or exhibits would be reserved for a later time during a different proceeding.

Steve Blair offered the following on behalf of DENR. The exhibits were accepted into the record.


