### V. EXECUTIVE DIRECTOR'S REPORT

Executive Director Olson reported that a group of Directors and staff are currently attending the HFA Institute in Washington DC. It covers many subjects and has HUD leadership and staff presenting sessions, which is a good learning opportunity for staff. He also mentioned that the Mountain Plains Housing Summit is being held May 5-7, 2025, in Jackson Hole, WY, and asked Commissioners to let him or Michele know they plan on attending. Executive Director Olson added the SD Legislative Session has begun, and the Authority will be monitoring the process and paying attention to any bills that may impact housing. He also announced that the annual Point in Time homeless count is on January 28, 2025. The Homeless Consortium partners with organizations across South Dakota to count the sheltered and unsheltered households. In closing he also gave an update on the Grant for Grads program, which assists recent graduates in purchasing homes and is now at 652 grants totaling almost \$7.8 million in grant funds and continues to be well received. He stated that the Authority is on track to make its goal of 1,000 grants.
