- c.) that the Respondent complete a course of continuing education that covers ethical considerations regarding social media use by educators;
- d.) that the Respondent not engage in or become party to any illicit relationships with students;
- e.) that upon completion, of any evaluations/exams/courses, that the Respondent provide written proof to executive secretary of the Professional Teachers Practices and Standards Commission (PTPSC); and
- f.) that at the request of the PTPSC Chair, the Respondent shall personally appear in front of the commission to address compliance with these terms and conditions,

and that the Chair be authorized to execute the Findings of Fact and the Conclusions of Law and Order along with the complaint to the secretary. Roll call vote, all in present voted in favor. Motion carried.
