V **EXECUTIVE DIRECTOR'S REPORT**

Interim Executive Director Olson reported that the Mountain Plains Housing Summit will be held May 8 through May 10, 2023 in Sioux Falls and the Housing Conference will be held June 27 through June 28, 2023 in Pierre. He stated the Housing Trust Fund and HOME Housing Development Officer position that has been open for approximately 10 months has been filled. Interim Executive Director Olson reported April was Fair Housing month and that South Dakota Housing sponsored several trainings across the state.

VI. **OLD BUSINESS**

Α. Resolution to Approve Revised Draft Housing Resolution No. 23-05-20: Infrastructure Financing Program Administrative Rules, Authorize Release for Public Comment, and Establish a Public Hearing; and to Withdraw the **Draft Housing Infrastructure Financing Program Allocation Plan**

After review and discussion, it was moved by Commissioner Erickson and seconded by Commissioner Hohn that the above Resolution be adopted as follows:

WHEREAS, South Dakota Senate Bill 41 ("SB 41") established a program for housing infrastructure loans and grants, made an appropriation therefor. and declared an emergency;

WHEREAS. SB 41 became effective on February 1, 2023, and has been codified as SDCL Chapter 11-15;

Board Minutes Page 2 of 4 WHEREAS, pursuant to SDCL 11-15-2, the housing infrastructure fund was created, to be administered by South Dakota Housing Development Authority ("SDHDA") for the purpose of making loans and grants for housing infrastructure projects;

WHEREAS, SDCL 11-15-6 provides that SDHDA shall promulgate rules pursuant to SDCL Chapter 1-26, specifying the criteria and process for the application, approval, and disbursement of the loans and grants;

WHEREAS, pursuant to SDHDA Resolution No. 23-03-18, adopted March 14, 2023, the board of commissioners of SDHDA approved the Draft Housing Infrastructure Financing Program Allocation Plan, dated March 14, 2023 (the "HIFP Plan") and authorized the public distribution of the HIFP Plan;

WHEREAS, pursuant to SDHDA Resolution No. 23-03-19, adopted March 14, 2023, the board of commissioners of SDHDA approved the Draft Housing Infrastructure Financing Program Administrative Rules (the "Draft Rules");

WHEREAS, SDHDA wishes to withdraw the HIFP Plan;

WHEREAS, SDHDA has revised the Draft Housing Infrastructure Financing Program Administrative Rules (the "Revised Draft Rules"); and

WHEREAS, SDHDA wishes the Revised Draft Rules to replace and supersede the Draft Rules.

NOW, THEREFORE, BE IT RESOLVED, that the previously approved HIFP Plan is hereby withdrawn;

BE IT FURTHER RESOLVED, that the Revised Draft Rules are hereby approved by SDHDA;

BE IT FURTHER RESOLVED, that the Revised Draft Rules hereby replace and supersede the previously adopted Draft Rules;

BE IT FURTHER RESOLVED, that the Executive Director is authorized to take all actions required pursuant to SDCL Chapter 1-26 for final approval of the Revised Draft Rules, including taking written comment and establishing a public hearing on such rules; and

BE IT FURTHER RESOLVED, that the Executive Director is hereby authorized to make such changes to the Revised Draft Rules as may be required by the Legislative Research Council or the Interim Rules Review Committee of the South Dakota Legislature.
