## MINUTES OF PUBLIC HEARING South Dakota Board of Nursing

The South Dakota Board of Nursing convened at 9:00 a.m. on August 11, 2021, in the Dakota Meeting Room at the Holiday Inn Express located at 3821 West Avera Drive, Sioux Falls, South Dakota.

The purpose of the meeting was to conduct a public hearing on the proposed rules of the South Dakota Board of Nursing to consider changes to the administrative rules numbered §§ 20:48:03.01:01, 20:48:03.01:04; 20:48:05:01; 20:48:08; 20:48:09; 20:48:11; 20:48:14; 20:48:17; and 20:62:05 adopted under the authority of SDCL 36-2A-14, SDCL 36-9-21, SDCL 36-9A-41, SDCL 47-11E-20, and SDCL 47-11F-18.
