The effect of the rules will be clarify and update verbiage, remove unnecessary and redundant regulations, combine disciplinary action into one section for all chiropractic professions regulated, update Code of Ethics, clarify continuing education requirements, update eligibility requirements for chiropractic assistants and chiropractic radiographers, and reduce renewal fee for active chiropractic licenses.

The reason for adopting the proposed rules is to remove obsolete provisions, remove redundant regulation, provide clarity and make administrative rules more uniform and accessible.

After the public hearing, the Chiropractic Board will consider all written and oral comments it receives on the proposed rules. The Chiropractic Board may modify or amend a proposed rule at that time to include or exclude matters that are described in this notice.
