

**South Dakota Board of Chiropractic Examiners Meeting

Board attorneys Bill Fuller and Molly Beck were also on the call for a portion of the meeting. Dr. Bruce Albrecht joined the teleconference after executive session.

The South Dakota AG's office declined the Board's request for an official opinion or clarifying statement on the legality of the use/sale of CBD oil by chiropractors.

M/S McCracken/Odland that the board not take a position as to the legality of CBD oil following the passage of HB1008 and encourage chiropractors to consult with independent legal counsel before making an independent decision on the use/sale of CBD oil in their practice.

Marcia Walter presented the financial update. The state account has a balance of \$389,380.40 as of August 31, 2020.
