Describe the change the institution is seeking approval of.

Lake Area Technical College seeks approval for significant curriculum modifications in its Cosmetology program. Presently, LATC has a 3-term (two semesters, plus one summer session), 1500-hour Diploma program which will be expanded to a 4-term (three semesters, plus one summer session), 1500-hour Diploma under the proposed curriculum update. The revised curriculum will provide an enhanced structure to allow students more time to incorporate theory content into practical learning experiences and decrease the wait time they currently experience in Clinical settings. The changes will also allow Cosmetology faculty more daily time for preparation and quicker responses to student work and ensure proper faculty to student ratios are met in every setting, per state regulations.

LATC has been training and educating Cosmetologists since 1965. The program has graduated 1,649 individuals over the last 60 years, supporting the styling industry in our state and beyond. LATC is proud of this program and the impact it has made; the program is well-established with strong retention and placement rates. Despite a strong history of success, the LATC Administration, Cosmetology faculty, and program advisory board recognize the need to reconfigure the program to meet students' needs and structure the schedule to maximize faculty workloads.

To address the issues wrought in LATC's current Cosmetology schedule and curriculum, the proposed changes in this application move the required 44 hours of class and clinical time per week to approximately 30 hours of student time per week. The total credits in the program will adjust from 39.5 credits to 41.5 credits. The LATC Cosmetology Advisory Board Members unanimously supported the suggested curriculum changes at the March, 2025 meeting. In the board minutes, members and faculty listed the following information as justification for the curriculum changes:

1. 75% of the present Cosmetology students voted in favor of lowering the weekly hours and adding a third semester for future cohorts.

- 2. Faculty members will now be provided with hours of daily preparation and planning to work on curriculum, form assessments, and practice new methods. The present weekly schedule does not provide that time.
- 3. Students will be able to focus and practice more intentionally during clinicals if they are following a more traditional collegiate schedule that allows time for reflection on learning and guidance to complete homework when faculty are available.
- 4. Faculty believe that the new schedule will improve clinical floor productivity and customer relationships as students can be more prepared.
- 5. The majority of LATC Cosmetology students also work 20+ hours each week to earn income for their educational expenses.
- 6. LATC Cosmetology Board member Mary Drevecky reported that she can "definitely see the difference between the students who work and don't work during the week. The ones who work multiple hours, alongside going to school, are less enthusiastic, motivated, and outgoing."
- 7. The changes will provide a more collegiate learning and campus atmosphere for the Cosmetology students, but retain a high-quality experience.

After a thorough discussion of the potential positive and negative impacts, LATC Advisory Board members supported the new weekly schedule, curriculum changes, and additional third semester for incoming Cosmetology students.

While the program is currently successful, the proposed changes will create a closer alignment between industry standards and system graduation credit requirements, and provide a more reasonable school/work/life balance for students. Further, modernizing the curriculum will address the styling needs of salons and customers. The proposed curriculum ensures that students will have enough time to meet all of the program outcomes and accreditation content/hours, while still becoming proficiently prepared for the South Dakota Cosmetology Commission Licensure Exam.

This program is not an emerging field in South Dakota. This application requests a review of our updated curriculum and, as such, no letters of support are required.

Three other accredited schools providing a collegiate Cosmetology program exist in South Dakota:

- 1. Paul Mitchell The School in Rapid City
- 2. Stewart School in Sioux Falls
- 3. The Salon Professional Academy in Rapid City.

The combined yearly graduation rates of the three programs listed above, including the number of graduates from Lake Area Technical College, does not equal the statewide demand for new Cosmetologists in South Dakota. All four are accredited by the South Dakota Cosmetology Commission.

#### 1. Unmet Demand

The need for Cosmetologists in South Dakota is expected to increase. According to recent Lightcast data, in South Dakota the Hairdressers, Hairstylists and Cosmetologist field is projected to grow by almost 10% between 2023 and 2033. When only considering the counties within 90 miles of Watertown, the growth projection increases to 12.6%. Presently, there are 232 jobs available in this field with over 1,540 Cosmetologists employed in SD in 2022. Additionally, the average annual wage for Cosmetologists in South Dakota is \$40,890 (without tips). This salary provides an excellent return for the students who have invested their tuition dollars in a 41.5 credit Diploma program.

On a national level, over 80,000 employment positions are open in this field with a projected 6.5% projected growth. At present, over 571,000 Cosmetologists are employed nationwide. The national average annual wage is only slightly higher than in South Dakota.

Locally, the floor manager at Carousel Salon in Brookings, SD reported the need for 5 new stylists per year due to customer growth and projected retirements.

As the statistics show, the Cosmetology industry is growing. Consequently, LATC is preparing to serve a larger cohort of incoming Cosmetology students. The new 4-term curriculum model does not significantly add to our students' overall tuition costs. Since the Diploma only increased by 2 credits and the required state accreditation clock hours remained the same at 1500, the revised curriculum meets all Financial Aid eligibility, helps provide the yearly industry demand for new stylists in the state and region, and aligns with the length of other Cosmetology programs in South Dakota.

Overall, the LATC Cosmetology curriculum is the basis of a well-established and widely-recommended program and on target to supply highly-trained Cosmetologists to help fill the need in South Dakota and beyond.

#### 2. Increases Student Access

By lowering the number of class and clinical hours from 44 to 30 per week, LATC will better serve our student's academic, fiscal and emotional well-being. Establishing a more reasonable school/work/life balance will offer our students an enriched learning environment, provide additional hours to seek employment for improving their financial circumstances, if needed, and allow instructors the time to initiate innovative styling techniques much desired by the industry and customers as a whole.

At the March, 2025 Advisory Board meeting, member Diane Pederson (owner of Salon 2000) was asked if the addition of a third semester would affect job placement in the industry, as this schedule would technically take students longer to graduate. Diane explained that "It would not affect anything. Salons are constantly changing, and it is a benefit that cosmetology has two different start dates." She added, "This change would help with having a more focused education, in that students have the ability to learn outside of the basics. They can walk into a salon and be seasoned in different techniques for hair coloring, etc."

Dr. Mitchell Chapel, a distinguished educator from Spearfish, SD and one of the State Directors of the SD Modernization and Restructuring program, wrote that in order for students to transfer their learning to Long Term Memory, a place where content is analyzed, comprehended and stored for future problemsolving, they will need to "linger over their learning." This proposed curriculum revision will provide the time and methodology for learning reflection and growth process to take place, cementing the knowledge and practice to produce seasoned Cosmetologists.

The LATC Cosmetology Diploma curriculum does not contain General Education courses as required by BP 301.1. The program was previously granted permanent exemption from the General Education course requirement by a Letter of Exemption from the SD Board of Technical Education. The program learning outcomes were developed and validated by LATC faculty and administrative staff. The outcomes were based on requirements for the Cosmetology State Board Licensure Exam. Advisory Board members also discussed and approved the Program Learning Outcomes in the March 2025 meeting.

All courses will contain assessment components. The assessments will be comprised of skills assessments, as well as formative and summative assessments both in the classroom and clinical environments.

All program courses leading to the degree will require a pass rate of at least 80% mastery. Post-graduation surveys conducted by employers and the college's placement report also help to determine the success of the program's graduates.

All LATC programs use SPOL assessment software to map curriculum and gather assessment data throughout the year. Annually, each department analyzes the assessment data. In addition, under the guidance of our Academics Department, each program creates an assessment and improvement plan annually.

The delivery method for this program will continue to be on campus. The Cosmetology training is highly handson and much of the skill training takes place during clinicals. The Cosmetology State Board requires students to be under direct supervision of a licensed instructor at all times to receive credit. Only 16 hours of their education is approved to be off-campus for mentoring a licensed cosmetologist in a licensed salon. For this reason, the program does not lend itself to an online or blended format.

Consequently, the Cosmetology curriculum does not align with other programs at LATC.

Re: Request for Exemption from Academic Program Policy 301.1.

Mr. Wendell:

Pursuant to the Memorandum of Understanding Board on Policy 301.1., this letter is to provide the list of each program at Lake Area Technical College that does not meet requirements established by BP 301.1. and request exemptions.

Lake Area Technical College offers four diploma programs that do not meet the criteria outlined in the State Board of Technical Education Board Policy 301.1. Program Award Level Definitions and Requirements: Aviation Maintenance Diploma, Cosmetology Diploma, Dental Assisting Diploma, and Paramedic Diploma.

Lake Area Technical College requests permanent exemptions from the Section 3.4. General Education requirement for the Aviation Maintenance Diploma, Cosmetology Diploma, Dental Assisting Diploma, and Paramedic Diploma. All four diploma programs are approved by the Higher Learning Commission, Department of Education, and program-level accreditation or licensure organizations. The general education skills are incorporated into the program coursework in these programs. Adding general education course requirements to the diploma programs exceeds the standards established by the accreditation and/or licensure organizations and, more importantly, industry. Increasing the number of credits would unduly increase the overall cost of education for our students, impacting affordability and access to technical education.

In addition, the college requests an exemption from Section 3.3. Program Length requirement for the Aviation Maintenance diploma. This diploma program exceeds the maximum credits outlined for diploma programs. However, the curriculum is aligned with the Federal Aviation Administration (FAA) Airframe (A) and Powerplant (P) Certificate, a credential required to work in the profession.

The exemptions requested are outlined below with the date established and the program-level accreditation or licensure information:
