## South Dakota Department of Health Notice of Public Hearing to Adopt Rules

A public hearing will be held on October 20, 2022, at 1 p.m. at the Hamlet Professional Building, 4001 W. Valhalla Blvd., Suite 202, Sioux Falls, SD 57106, and via zoom\* to consider the adoption of proposed rules numbered:

20:51:35:01, 20:51:35:02, 20:51:35:03, 20:51:35:04, 20:51:35:05, 20:51:35:06, 20:51:35:07, 20:51:35:08, 20:51:35:09, 20:51:35:10, and 20:51:35:11.

The effect of the proposed rules ARSD §§ 20:51:35:01 through 20:51:35:11 will be to provide the framework for the Redistribution of Donated Prescription Drugs and Medical Supplies program which was created with the passage of HB 1086 in the 2022 Legislative Session and is now SDCL 34-20-H.

The reason for adopting the proposed rules is for the board to be able to develop and implement the provisions of SDCL 34-20H. These rules define how the Board of Pharmacy develops and administers the program, and how participating pharmacies manage and dispense donated drugs and supplies.

Persons interested in presenting data, opinions, and arguments for or against the proposed rules may do so by appearing in person or via zoom\* at the hearing or by sending them to the South Dakota Board of Pharmacy, 4001 W. After the hearing, the Board of Pharmacy will consider all written and oral comments it receives regarding the proposed rules. The Board of Pharmacy may modify or amend a proposed rule at that time to include or exclude matters that are described in this notice.
