

Total Project Cost: \$29,760,481

Staff Analysis

- 1) The Air Force has partnered with South Dakota Ellsworth Development Authority (SDEDA) to complete a community water system design to provide drinking water supply to PFOS and PFOA impacted private properties identified by the Air Force
- 2) SDEDA plans on building capacity above the Air Force requirements to help address broader regional water needs being addressed in a separate regional study. The new water line could provide water supply to the regions north of Rapid City, east of Black Hawk, and to New Underwood.
- 2) SDEA has not secured the necessary state permits to proceed with the project and Meade County has also denied the water pipeline permit application.

Funding Recommendation: No Funding - Application withdrawn



APPLICANT: Terry Trojan Water Project District DW-03

Total Project Cost:\$1,175,303BWNR Funding Assistance Requested:\$700,000Rate/Term:1.875%/10 YearsSecurity Pledged For Repayment Of Loan:System Revenue

Staff Analysis

- 1) Terry Trojan WPD is seeking funding for their water meter project. This project was partially funded with their DW-01 loan, but due to increased project costs, more funding is needed. The remaining funds on the DW-01 loan are \$375,307.
- 2) Current rates for Terry Trojan WPD are \$95/7,000 gallons usage and the current coverage is at 100%, which is below the required 110% debt coverage.
- 3) The system applied for a 30 year loan, but water meters only have a life expectancy of 10 years.

Funding Recommendation: Award a \$700,000 Drinking Water SRF loan with up to 42.9% principal forgiveness not to exceed

\$300,000.

Debt Service Coverage: 110% with rates of \$110/7,000 gallons.

Loan Contingencies:

- 1) Contingent upon the Borrower adopting a bond resolution and the resolution becoming effective.
- 2) Contingent upon the Borrower establishing rates at a level sufficient to provide the required debt coverage.
- 3) Contingent upon receipt of the 2022 Drinking Water State Revolving Fund capitalization grant from EPA.

Staff Analysis

1) Clay Rural Water System is proposing a project to address deficiencies caused by population growth and higher water demands.

2) Staff analysis has determined at their current rate of \$77.10/7,000 gallons they would only have 55% loan coverage and will need to increase rates to maintain the 110% debt coverage.

Funding Recommendation: Award a \$21,843,000 Drinking Water SRF loan at 2.125% for 30 years.

Debt Service Coverage: 111% with rates at \$117.10/7,000 gallons.

Loan Contingencies:

- 1) Contingent upon the Borrower adopting a resolution approving the form of the loan agreement, the promissory note, and the pledge of revenues for repayment of the loan.
- 2) Contingent upon the Borrower approving a security agreement and mortgage.
- 3) Contingent upon the Borrower establishing rates at a level sufficient to provide the required debt coverage.
- 4) Contingent upon an Intercreditor Agreement being approved and executed by CoBank, Clay Rural Water System and the District.

2) If funding is provided as all loan, the city will have to establish a surcharge of approximately \$20.10 per month

3) At the recommended level of loan funding, Brookings will need to increase its rates to \$61.85 per 5,000 gallons

Funding Recommendation: Award a \$40,700,000 Drinking Water SRF Loan at 1.875% for 30 years

Debt Service Coverage: 110% based on a \$20.10 surcharge

Loan Contingencies:

1) Contingent upon the Borrower adopting a bond resolution and the resolution becoming effective.

2) Contingent upon the Borrower establishing a surcharge at a level sufficient to provide the required debt coverage.

Funding Recommendation: Award a \$1,000,000 Drinking Water SRF loan at 1.875% for 30 years with up to 49% principal forgiveness



Debt Service Coverage: 963% with rates of \$53.00/ton.

- 2) Contingent upon the Borrower executing Joint Powers Agreement between the city of Vermillion, the city of Yankton, Clay County and Yankton County.

Staff Analysis

1) Sioux Falls is proprosing a project to construct a new trunk line near 12th Street and Ellis Road to accomadate future needs.

- 2) Staff analysis has determined at their current rates of \$41.06 the city would have the required debt coverage to cover a new loan.
- 3) The loan will conisist of two series a \$16,711,000 series for the Basin 15 Sanitary Sewer Extension project and a \$1,240,000 series for the nonpoint source project.

Funding Recommendation: Award a \$17,951,000 Clean Water SRF loan at 1.25% for 20 years.

Debt Service Coverage: 129% based on current rates.

Loan Contingencies:

1) Contingent upon the Borrower adopting a bond resolution identifying both series and the resolution becoming effective.

Loan Special Condition:

1) It shall be a condition of the Loan that the Borrower may not draw funds from the proceeds of the Series NPS Borrower Bond until EPA approves the revised budget for the Big Sioux Watershed Implementation Project.


