RE: Open Meetings Violation Complaint

To whom it may concern:

I received a complaint that alleges a violation of the open meeting laws. After completing my investigation, and pursuant to SDCL 1-25-6.1 (3) I am referring this matter to the South Dakota Open Meetings Commission for further action.

Attached is a copy of the July 7, 2021, Commissioner meeting Agenda. Nowhere on the agenda does it mention an Executive session with the Sheriff or does it mention a raise for the Transport Officer. I reviewed the audio recording of the July 7, 2021, meeting and at approximately 2:13:00 in the recording, the commissioners come out of executive session with the Sheriff and his Deputy and took action and made a motion to give Sheriff Transport Officer Bucholz a raise to \$14.25 per hour, increasing the hourly wage by 0.75 cents. (See attached audio from 7-7-21) Prior to going into executive session the commissioners told the newspaper that they could leave because no action would be taken when they come out of executive session.

I also reviewed the audio recording of the August 4, 2021, commissioner meeting and at approximately 55:50 in the recording, the Sheriff mentioned being in executive session with the commissioners on July 7th and that they discussed in executive session the raise for Stuart Bucholz the Sheriff's transport officer. The Sheriff stated that he asked for \$14.50 but in order to keep Stuart's annual 0.50 cent raise they compromised with the commissioners and agreed on \$14.25. (See attached audio from 8-4-21) This whole conversation would have taken place in executive session.

I am also including with this letter a copy of the Board of Bennett County Commissioners Minutes for Wednesday, July 7, 2021, and the letter of complaint.

I would like to file a formal complaint against the Bennett County Board of Commissioners. Jeff Slattery Chair, Rod Kirk Vice Chair, David Bakley, Cole Blu Donovan, and Judd Schomp for open meeting law violations. During the July 7, 2021 the board went into executive session with the County Sheriff Paul Williams. We were all told before the executive session started that nothing was going to be voted on or discussed after they came out of session so everyone including the representative from the Booster did not return to the meeting room. During the budget meeting on July 12, 2021 a new wage for an employee was mentioned, a raise that I was not aware of. On July 13, 2021 I asked Auditor Angie Hicks about the wage and was told that the Commissioners approved the \$.75/ hour raise at the last

There was nothing on the agenda regarding the raise. I believe this was discussed and voted on during the executive session. That and the fact that it was not on the agenda I believe the Commissioners did violate the open meeting laws the State of South Dakota has set before us.

BOARD OF BENNETT COUNTY COMMISSIONERS MINUTES OF PROCEEDINGS

WEDNESDAY, JULY 7TH, 2021 MARTIN, SOUTH DAKOTA

The Bennett County Board of Commissioners met in regular session Wednesday, July 7th, 2021 in the Courtroom.

Commissioners Present: Judd Schomp, Rod Kirk, Jeff Slattery, and Dave Bakley.

Absent: Blu Donovan.

Others Present: Angie Hicks, Auditor; Jaci Clifford, Register of Deeds; Jesse Ulmer, Highway Labor; Paul Williams, Sheriff; Jason Erwin, Sheriff's Chief Deputy; Jolene Donovan, Treasurer; Jeff Siscoe, Director of Equalization; Kris Jacobsen Executive Director of SDACC & SDACO; Cliff Reuer, SDLTAP; Taylor Risse, Booster; Sarah Harris, States Attorney; Bennett County Conservation District Representatives: Carl Novotny, Gloria Claussen, Jim Good, and Kenneth Bolzer;; Area Residents: Leroy Guptill, Bill Kocourek, Steve Livermont, Stevan Hauck, Wayne Sterkel, Dennis Gregg, Rolf Kraft, Brian Jager, Bo Sharp, and Bob Ceplecha.

Chairman Jeff Slattery called the meeting to order at 9:30 a.m.

Kris Jacobsen, Executive Director of SDACC & SDACO, introduced herself to the Board and explained what the South Dakota Association of County Commissioners and South Dakota Association of County Officials does for all the Counties in South Dakota. There was discussion held concerning the Commissioners handbook, County Convention and the ARP money for the U.S. Treasury.

Cliff Reuer, SDLTAP, informed the Board about South Dakota Local Transportation Assistance Program. Mr. Reuer also informed the Board that they come down and can help with training and other services at no cost to the County as it is covered by the STP money. The Board asked about grants for helping with the cost of building up roads? Mr. Reuer stated that Doug Kinniburgh or Paula Huizenga would be good contacts to help with grants. There was further discussion held concerning training and grants for highway departments.

Ms. Jacobsen provided more information concerning the HB1259 Rural Access Infrastructure for small structure inventory around the County. Angie Hicks, Auditor, stated Bennett County will receive roughly \$25,000. Ms. Jacobsen stated the funds can be used to hire someone to gather all the inventory for the County, or the County can do it themselves. The small structures are considered culverts with 16sq ft opening or bridges less than 20 ft long. There was further discussion held concerning HB1259. Mr. Reuer stated the County should get right on gathering this inventory information. Ms. Jacobsen stated that they have to GPS every unit and then enter it into a spreadsheet, and more guidelines will be provided by August 1st.

Sarah Harris, States Attorney, did the second reading of Ordinance #1-2021 Temporary Ordinance Regarding the Issuance of Local Medical Cannabis Establishment Permits and/or Licenses. Chairman Slattery called for any public comment, there being none Rod Kirk makes the motion to approve Ordinance #1-2021 Temporary Ordinance Regarding the Issuance of Local Medical Cannabis Establishment Permits and/or Licenses. Judd Schomp seconded.

All Voted Aye. Motion Carried.

BENNETT COUNTY ORDINANCE NO. 1-2021

A TEMPORARY ORDINANCE REGARDING THE ISSUANCE OF LOCAL MEDICAL CANNABIS ESTABLISHMENT PERMITS AND/OR LICENSES.

WHEREAS, a local government may enact an ordinance not in conflict with SDCL Chapter 34-20G, governing the time, place, manner, and number of medical cannabis establishments in the locality. A local government may establish civil penalties for violation of an ordinance governing the time, place, and manner of a medical cannabis establishment that may operate in the locality. A local government may require a medical cannabis establishment to obtain a local license, zoning permit, or registration to operate, and may charge a reasonable fee for the local license, zoning permit, or registration.

WHEREAS, Bennett County, SD ("County"), makes a preliminary finding that the County's current regulations and controls may not adequately address the unique needs and impacts of medical cannabis establishments as defined in SDCL 34-20G-1;

WHEREAS, medical cannabis state laws under SDCL 34-20G are effective July 1, 2021. The South Dakota Department of Health is required promulgate rules pursuant to chapter 1-26 no later than October 29, 2021, as defined by SDCL 34-20G-72. During the time between July 1, 2021 and potentially as late as October 29, 2021, local units of government will not yet know standards for medical cannabis and will not be able to adequately assess the local zoning and licensing requirements necessary to approve local permits and to better ensure applicants have a more predictable permitting process and avoid stranded investments.

WHEREAS, the County makes a preliminary finding that the County needs further study of the relationship of medical cannabis establishments to the County's desire and need to protect the community. The public interest requires that the County study, analyze, and evaluate the impacts of medical cannabis establishments and to fully explore the impacts of any proposed regulations regarding medical cannabis establishments.

WHEREAS, the County makes a preliminary finding that it would be inappropriate for the County to issue a local permit or license to a medical cannabis establishment prior to the South Dakota Department of Health's promulgation of regulations governing the same;

WHEREAS, the County hereby exercises its authority under SDCL 11-2-10 and SDCL 7-18A-8, to establish a temporary ordinance regarding the issuance of any local permits/licenses for medical cannabis establishments within the County;

WHEREAS, a temporary ordinance will ensure that more comprehensive regulations and ordinances for issuing licensing permits, can be completely examined with adequate public input from citizens, business interests, and medical cannabis industry representatives;

WHEREAS, the County finds that a temporary ordinance is reasonable to preserve the status quo and prevent significant investment pending the outcome of the above study and any proposed regulations or ordinances emanating therefrom;

WHEREAS, the County finds that the following ordinance is necessary to protect and immediately preserve the public health, safety, welfare, peace and support of the county government and its existing public institutions;

NOW, THEREFORE, BE IT ORDAINED BY BENNETT COUNTY, SOUTH DAKOTA THAT:

Section 1. Temporary Ordinance - Application for Local Permit/License

A medical cannabis establishment desiring to operate in the County shall be required to apply for a permit and/or license from the County. Applications for a local permit and/or license to operate a medical cannabis establishment, as defined by SDCL 34-20G-1, shall not be accepted until the South Dakota Department of Health has promulgated regulations as required by SDCL 30-20G-72. Any application received prior to such regulations being promulgated shall be denied.

Section 2. Immediate Effect.

This ordinance is necessary to protect and immediately preserve the public health, safety, welfare, peace, and support of the county government and its existing public institutions pursuant to SDCL 11-2-10 and SDCL 7-18A-8.

Reports

June - Register of Deeds: \$2,869.50

Chairman Slattery informed everyone of an incident that occurred yesterday between himself and Jesse Ulmer, Highway Labor. Chairman Slattery was informed of some maintenance needing done on a machine that Bob Ceplecha had borrowed so he and Mr. Ceplecha went out to the highway shop to get the machine maintained, and found that the emergency kill switch had been shut off. Mr. Ulmer came to the shop and he had a problem with Mr. Slattery being at the highway shop because he is not an employee, and Mr. Ulmer continued to state that Ms. Harris stated Mr. Slattery couldn't be out there for the same reason as he is not an employee. Mr. Slattery went to Ms. Harris' office and asked why he isn't allowed at the shop because he is an employee. Ms. Harris stated that she never said Mr. Slattery couldn't be out there. Chairman Slattery continued that he didn't end up getting the machine maintained because Mr. Ulmer had a problem with him being out there, so the incident occurred and nothing got accomplished and it would have been volunteer work for the County. Commissioner Kirk asked what is your reason Jesse? Mr. Ulmer stated its security, and you don't have a key for the Courthouse. Commissioner Bakley stated that is not the same as the Courthouse, it's the County Shop and we are in charge of it. Mr. Ulmer stated it's a security issue. Commissioner Kirk stated for who, you are an employee, not the highway superintendent. You were going to get something done for free, and now you have to do this, and I am requesting that you get this done today and be done by the end of the day. Mr. Ulmer stated that won't be possible because I don't have the right cutting edges. Chairman Slattery stated that all you have to do is cut one foot off the end and put it on there. Chairman Slattery continued that a couple months ago you and Steve came out and wanted to borrow a drill, and I said no problem and now you are throwing me under the bus for going out there trying to help, and threating to call the Sheriff, why would you do that, what did I ever do to you? Mr. Ulmer stated its security. Bob Ceplecha, Area Resident,

stated yesterday you said it was a liability issue and today it's a security issue make up your mind, and you told us yesterday that Sarah said we couldn't be out there and we find out that was a lie again. Mr. Ulmer stated I asked if he was allowed there when no one was there and she said no. Ms. Harris stated she did not say that. Mr. Ulmer said yes you did, I recorded you. Ms. Harris stated okay, well I never said that. Commissioner Bakley stated that I make a motion we make Ed Johnson the temporary highway superintendent. Chairman Slattery stated let's hold off on that for a little while. Commissioner Schomp stated we have more to discuss. Commissioner Bakley stated okay. Commissioner Schomp stated we need a boss out there. Chairman Slattery stated yes, we do. When you have a volunteer to go out there to help and they get ran off, that can't happen. Commissioner Kirk stated that he and Dave Bakley were put in charge of the highway crew, and he requested the work to get done since it could've been done yesterday. Now it needs to be done today so that blade can be used. Commissioner Schomp stated the Commissioners cannot be in control of the highway department because there is no recourse if something doesn't get done, it comes back on the employee told to do it. Rod Kirk makes the motion to go into executive session at 10:20 a.m. concerning personnel with Angie and Sarah. Dave seconded.

Voting Aye: Rod Kirk, Jeff Slattery, and Dave Bakley.
Voting Nay: Judd Schomp.
Motion Carried.

Bo Sharp, Highway Labor Applicant, joined executive session at 10:30 a.m.

Chairman Slattery declared executive session closed at 10:55 a.m. Jeff Slattery makes the motion to hire Bo Sharp as Full-Time Highway Labor effective July 26, 2021 and salary to be determined at a later date. Rod Kirk seconded.

All Voted Aye. Motion Carried.

The Board decided to table the certification training in Pierre for the next meeting on July 21, 2021.

Discussion was held concerning surplusing the yellow truck (Peterbilt). The Board decided to be on the look-out for a Semi Truck, and a flatbed truck and put a water tank on it. Commissioner Kirk is checking with Jeff at Grossenburg Implement concerning a mower and he will be sending some information. Commissioner Schomp stated he checked with Wade at RDO and they have no mowers available.

Bob Ceplecha, Area Resident, informed the Board that they gave us about 300 ton more of millings, and there is about 650 ton left to haul, but that 300 ton has some bigger chunks in it, so it will need to be screened. There was further discussion concerning the millings to go on Old Highway 18. Mr. Ceplecha asked about continuing maintenance on Hisle Road? The Board stated that they would let them know when to go back out and maintain Hisle Road. Brian Jager, Area Resident, informed the Board that his concerns are the blowouts on Hisle Road, they are busting up trailers while hauling cattle. The cattle can potentially get hurt, and he has to insure the cattle. Mr. Ceplecha asked what material to use in the blowouts on Hisle Road? Chairman Slattery stated that they have used Judd's rock in different places to fix holes. Mr. Ceplecha stated that some residents are not happy with that material, on Miller Hill there are big rocks in the middle of the road. Commissioner Kirk stated that there needs to be gravel put over that base material. Commissioner Schomp stated that the big rocks didn't come out of his pit, but not sure

where they came from. Mr. Ceplecha stated that Bauman gravel would be good to put on Hisle Road. There was further discussion held concerning graveling and watering Hisle Road to get it fixed. Commissioner Bakley stated what about the rest of the blowouts throughout the County, he has had several complaints from residents by Eileen Kamerzell's and Huddleston's place. The Board stated once heavy hauling is done then they can go and repair the other blowouts. Mr. Ceplecha stated that Jonathan Bad Wound approached him about not being asked to haul for the County and when I put my bid in for hauling Jonathan, Prang, Hicks, and Weber all run under my bid. Ms. Harris stated that you have to contact all the ones that bid for hauling and if they can't haul then you can contact other haulers. Mr. Reuer stated that they would be treated as a sub-contractor and Mr. Ceplecha would have to pay those under his bid. Commissioner Kirk stated that we may have to re-bid the hauling since a lot of haulers missed the bid and didn't bid it out.

Auditor Hicks stated this \$175,000 was set aside years ago for a project, but it fell through, and therefore this money is still restricted. Auditor Hicks asked if the Board wants to leave it restricted or put it in the road & bridge fund? The Board was in agreement to leave it as restricted money for now.

Dennis Gregg, Area Resident, stated that filling the holes on Old Highway 18 has worked, but it isn't being done anymore, and we keep hearing about it being ground up and none of us residents want that to happen, and asked if it is going to happen? Commissioner Kirk stated that isn't going to happen. Chairman Slattery stated that it might be done to Hisle Road, because we need something done to that road that is going to last. Mr. Ceplecha stated they had been broke down, but will get back to repairing Old Highway 18.

Wayne Sterkel, Area Resident, presented the Board with a list of questions that he wants answered in writing by the Board concerning right of ways. Mr. Sterkel stated one of the questions is can a landowner close a section line with a fence? Commissioner Kirk stated we found out that a landowner can, as long as there is access to it, with a gate on each end. Mr. Sterkel continued that he would like these answers in writing because he has talked to Sarah Harris, and the Sheriff and nothing gets done with the gates, and maybe the Board would have a little more authority than he does. Mr. Sterkel's next question is if a landowner builds a fence on someone else's property without permission is that legal or is that trespassing? Mr. Sterkel continued is repairing a fence the same as building new? Mr. Sterkel stated that it was retracted in the Booster that it was not a new fence it was rebuilt, and who would own the fence? Commissioner Kirk stated that we have no jurisdiction here. Mr. Sterkel stated that I would like that in writing. Ms. Harris stated that this is what can happen, so the landowner can erect a fence across an unimproved section of the highway, and the landowner has to provide a gate at each end so the public still has access. Ms. Harris continued that if the request is filed, the jury may request the sheriff to notify the landowner, and the landowner shall comply with the provisions within 7 days of the notice. Mr. Sterkel stated this goes outside of the section line and is that legal? Commissioner Kirk stated that this is probably going to be civil. Mr. Sterkel stated that will cost \$5,000 to \$10,000 and I can't afford that, these posts got put in there and I talked with Nathan's wife, and an attorney stated that I could take those posts out and the next thing I know the Sheriff put yellow tape on the fence, and I can't touch it, and it's on my property. Sheriff Williams stated that he got a call from dispatch that a fence was going to be taken out and that firearms were going to be involved so therefore I put the yellow tape around the fence until I

could find out the entire issue. Sheriff Williams stated that he then talked to Mr. Sterkel and found out what the issue was and that Mr. Sterkel stated he wasn't going to take the fence out. Mr. Sterkel stated that he is taking care of this on behalf of his mom as he is her power of attorney. There was further discussion held concerning this issue and County right of ways.

Bill Kocourek, Area Resident, asked why County money would be wasted on putting a culvert in an approach that has never run a drop of water? Commissioner Kirk stated that was a misunderstanding we were told that it was needed there. It was stated that the Highway Dept needs to work with landowners. Jeff Siscoe, Emergency Manager, stated there is slope there and so I thought that there was a need for the culvert. Mr. Kocourek stated it actually runs to the West not the East. Steve Livermont stated that he thought that the culvert was buried so when he dug down about half way he went ahead and put the culvert in, and he agreed with Bill and stated it shouldn't have been done. Mr. Kocourek stated that he wanted to let the Board know that Steve York came out and bladed his road, and he did a great job with what he had to work with.

Stevan Hauck, Area Resident, informed the Board of an issue on 211th Avenue that the dust is so bad on that road and they almost got ran over by some trucks, but the road base itself has disintegrated and needs the first half mile to be graveled. Mr. Reuer stated that it would be a good idea to put out a policy on culverts and care & maintenance of the roads. Commissioner Kirk stated that Heather Harris needs a speed limit sign by her house as the traffic is going way to fast, and her kids run back and forth on that road. Jason Erwin, Chief Deputy, stated they are patrolling the area, but there are a lot of roads to patrol as well and they are doing their best. Commissioner Kirk stated to get some signs ordered to put up out there.

Auditor Hicks stated that True North Steel stated that they pulled their bid for 2021 since they couldn't honor their prices as bid in January since the prices on everything has gone up. Auditor Hicks stated that Beadle County is going to rebid it and then will let us know how that goes the end of this month.

Sheriff Williams presented the Board with the June report. Sheriff Williams would also like to have a meeting with a couple of the Commissioners, Hospital Board, OST Public Safety Chief, and States Attorney Sarah Harris concerning mental holds. Sheriff Williams continued stating that there has been an increase in the mental holds and most of them are from other counties. Sheriff Williams would also like to get a contract with South Plains Behavioral Health in Winner and he feels that would help with some of the cost for mental evaluations when they are intoxicated. The Board thinks that the contract would be a good idea so Sheriff Williams is going to work on that contract.

The Board decided to table the hiring of Larry Livermont, and Bo Sharps salary until the next meeting on July 21, 2021.

Auditor Hicks informed the Board that Stella Poor Bear is working 30 hours in the Treasurer's Office and 10 hours a week in the Register of Deeds Office.

Judd Schomp makes the motion to approve Shane Boomer as a deputy Coroner effective June 28, 2021. Rod Kirk seconded.

All Voted Aye. Motion Carried.

Jeff Siscoe, Emergency Manager, stated that if he is given a subpoena for the surveillance video footage that he still has to get written permission with two signatures from the

Commissioners to obtain the footage, and he would like to know if with the subpoena he could just get the footage requested without the Commissioners permission? The Board would like him to just let them know when some footage was requested by subpoena and keep a list of when it was requested. Mr. Siscoe stated that he already keeps a log of all footage requested. Rod Kirk makes the motion to give Jeff Siscoe permission to release video surveillance when presented with a subpoena without requiring two Commissioners signatures. Jeff Slattery seconded.

All Voted Aye. Motion Carried.

Kenneth Bolzer, Bennett County Conservation District Representative, informed the Board that they are requesting \$9,000 for the 2022 budget from the Commissioners. Mr. Bolzer explained that they need to repair a drill that they loan out to local people, and Patty Beck hasn't had a raise since 2018 and they would like to give her a raise. There was further discussion held concerning the drill loaned out and the Conservation program needs.

Commissioner Kirk asked what the burn ban is all about? Bob Ceplecha, informed the Board on an incident and stated that he couldn't go into May's Pit so then Jesse went out and raised hell with his boys saying that they couldn't fix the road, and they screwed up the roads and we can't get into any gravel pits, and he wants it nipped in the butt because he doesn't know where that comes from aside from May's he can go in to any gravel pit. Commissioner Schomp stated that Jesse reported that Mr. Ceplecha was going to fix the blowout on Hisle Road. Mr. Ceplecha stated no we were hauling into Billy Mansfield's and the blowout was already there, and he just wanted that cleared up.

Dave Bakley makes the motion to go into executive session concerning personnel with Sheriff Williams and Jason Erwin, Chief Deputy at 12:10 p.m. Rod Kirk seconded.
