**Approval of Agenda – Chairman Tim Ostrem**

**Joint Domestic Committee Budget Recommendation**

**Todd Hanten moved that SDSRP&C allocate \$50,000 for the Joint Domestic Committee to spend on four projects: PoreShield concrete preservation, Goodyear Tire Promotion, BioBlend Dust Suppressant and soy-based 5th wheel grease pads. Seconded by David Struck.**

**Mike McCranie moved to amend by striking all words after “allocate” and replace with: \$25,000 for the Goodyear Tire Promotion, \$15,000 for the PoreShield Concrete Project, \$3,000 for the Promotion of the PoreShield Project, \$5,000 for the 5th wheel Grease Pad Promotion, and \$10,000 for the BioBlend Dust Suppressant Project in the FY21 budget year. Seconded by Heather Beaner. Amendment passed with 7 voting in favor and one opposed. Voting yes- David Struck, Heather Beaner, Mike McCranie, Dawn Scheier, Todd Hanten, Jason Frerichs, and Tim Ostrem. Voting no-Ardon Wek.**

**The main motion as amended: SDSRP&C allocate \$25,000 for the Goodyear Tire Promotion, \$15,000 for the PoreShield Concrete Project, \$3,000 for the Promotion of the PoreShield Project, \$5,000 for the 5th wheel Grease Pad Promotion, and \$10,000 for the BioBlend Dust Suppressant Project in the FY21 budget year. Motion passed unanimously.**
