A meeting of the SD Veterinary Medical Examining Board (Board) was called to order at 3:30 PM CST by Board President Dr. Alice Harty.

Dr. Harty and Board members Dr. Roland Good and Craig Dybedahl were in person. Also attending were Dr. Beth Thompson, State Veterinarian and Executive Director of the Board, and Legal Counsel Drew Duncan.

The agenda for the meeting was unanimously approved upon motion by Craig Dybedahl and seconded by Dr. Good. Dr. Joseph Spoo was not present.

Minutes of the January 27, 2023 Board meeting were unanimously approved upon motion by Craig Dybedahl and seconded by Dr. Good.

The Board entered executive session at 3:34 p.m. upon a motion by Craig Dybedahl and seconded by Dr. Good in order to consult with legal counsel.

The Board exited executive session at 5:43 p.m. No action was taken.

Case #0227 The Executive Director reports she has appointed an investigative committee of Dr. Thompson and Drew Duncan. Upon motion of Dr. Good and seconded by Craig Dybedahl that appointment was approved. The motion passed.

Case #0228 The Executive Director reports she has appointed an investigative committee comprised of Dr. Thompson and Drew Duncan. Upon motion of Craig Dybedahl and second by Dr. Good, that appointment was approved. Upon report of the investigative committee that there was no finding that probable cause exists that there has been a violation of the standard of care or South Dakota Codified Law, Craig Dybedahl made a motion to dismiss the case, Dr. Good seconded. The motion was unanimously approved.

Case #0229 The Executive Director reports she has appointed an investigative committee of Dr. Thompson and Drew Duncan. Upon motion of Dr. Good and seconded by Craig Dybdahl, that appointment was approved. The motion passed. This investigation remains open.

Case #0230 The case was tabled until the next meeting pending the identification of an expert.

Case #0231 The case was tabled until the next meeting pending the identification of an expert.




Other Business:
