Date of Alleged Violation: November 29, 2023.

Statement of Material Facts: On November 29, 2023, from 11 a.m. to 1 p.m., NuGen Energy, LLC hosted an "Open House Event" at their production facility located at 27283 447th Ave, Marion, SD 57043. The invitation stated as follows: "Join us for a tour of the plant and background on why NuGen Energy has chosen to partner with Summit Carbon Solutions to lower their carbon intensity and secure a long-term market for ethanol". Members of the public as well as members of the Lincoln County Commission and the Lincoln County Carbon Dioxide Transport and Storage Advisory Committee received the invitation.

Issue 1: On December 5, 2023, a complaint was submitted to the Lincoln County State's Attorney's Office by Wendi Hogan, a Lincoln County resident, alleging that Lincoln County commissioners Mike Poppens, Jim Jibben, and Joel Arends were all present at the event without providing "public notice of a quorum" in violation of § 1-25-1.1. Wendi Hogan signed the complaint on December 8, 2023.

Commissioner Poppens and Commissioner Jibben confirmed their attendance at the meeting. Commissioner Poppens noted that he has and will continue to recuse himself on all carbon pipeline related issues. Commissioner Arends declined to comment. To our knowledge, the event had no posted agenda.

Issue 2: Further, complainant alleged that four (4) members of Lincoln County's Carbon Dioxide Transport and Storage Advisory Committee (Commissioner Arends, David Anderson, Commissioner Jibben, and Karla Lems (nonvoting member)) were in attendance as well. Complainant alleges that committee member attendance violates § 1-25-1.1 as well. Committee member David Anderson states that he planned to attend the event but ultimately did not do so due to a scheduling conflict. No contact was made with Karla Lems for the purpose of the investigation.

State of Legal Issues: Whether the Lincoln County Commission violated § 1-25-1.1 by failing to post an agenda or public notice of a quorum.

Whether the Advisory Committee violated § 1-25-1.1 by failing to post an agenda or public notice of a quorum.

State's Attorney Conclusions:

Issue 1: The alleged violation by the Lincoln County Commission may warrant review from this Commission.

Issue 2: As to whether the Advisory Committee violated § 1-25-1.1, the State's Attorney concludes that such complaint has no merit. First and foremost, the Advisory Committee is just that, an advisory committee. As stated by the Open Meeting Commission, committees that are advisory only may not be subject to open meetings law, but they are encouraged to comply to the extent possible.

Nonetheless, even if open meeting requirements are applicable to the Advisory Committee, the State's Attorney's Office finds no merit to the complaint. The Advisory Committee is comprised of 9 members, two of which are nonvoting members. To be considered a quorum, there would need to be at least 4 voting members, or 5 total Committee members, if nonvoting members are also considered. Only 3 voting members and 1 nonvoting member were in attendance. Even if David Anderson had attended the event, there would not have been a quorum of Committee Members. Therefore, the State's Attorney opines that there is no merit that Advisory Committee, or members of the Advisory Committee, violated § 1-25-1.1.

Legal Issues for Commission Consideration: Based upon the foregoing, the Lincoln County State's Attorney's Office requests the Open Meeting Commission consider whether the Lincoln County Commission violated § 1-25-1.1 for failing to a public notice of a quorum.

On December 11, 2023, I, Gary Harvison, Lincoln County States Attorney Investigator, spoke to Lincoln County Commission member Jim Jibben via telephone.

The purpose of the phone call was related to the Lincoln County States Attorney's Office receiving a complaint regarding a possible Open Meeting Violation related to an Open House event at the NuGen Energy facility on November 29, 2023.

During our phone conversation Mr. Jibben acknowledged attending the event. Mr. Jibben stated he was attempting to gather information related to the carbon dioxide business and how it related to recent attempts to build pipelines in the area. Mr. Jibben said he intended to gather information relevant to the district he represented as a commissioner and gather information as a private citizen/farmer. Mr. Jibben stated the capture of carbon dioxide is related to ethanol plants and ethanol plants are directly related to Mr. Jibben's farming practices.

Mr. Jibben said he believed good information was provided during the meeting.

On December 11, 2023, I, Gary Harvison, Lincoln County States Attorney Investigator, spoke to community member David Anderson via telephone.

The purpose of the phone call was related to the Lincoln County States Attorney's Office receiving a complaint regarding a possible Open Meeting Violation related to an Open House event at the NuGen Energy facility on November 29, 2023.

During our phone conversation Mr. Anderson advised that he had been invited to the event at NuGen Energy but Mr. Anderson did not attend.

On December 11, 2023, I, Gary Harvison, Lincoln County States Attorney Investigator, spoke to Lincoln County Commission member Mike Poppens via telephone.

The purpose of the phone call was related to the Lincoln County States Attorney's Office receiving a complaint regarding a possible Open Meeting Violation related to an Open House event at the NuGen Energy facility on November 29, 2023.

During our phone conversation Mr. Poppens acknowledged attending the event. Mr. Poppens explained he has recused himself from any official county business related to pipelines related to carbon dioxide capture or transportation. Mr. Poppens said he plans to continue to recuse

himself on related pipeline matters. Mr. Poppens stated he attended the meeting as a property owner in the county that may be affected in the future.

On December 11, 2023, I, Gary Harvison, Lincoln County States Attorney Investigator, spoke to Lincoln County Commission member Joel Arends via telephone.

I Wendi Hogan bring forth the following complaint of the Lincoln County Commission (Commission) being in violation of SDCL 1-25-1.



Commissioner Poppens has tried to say that his presence at this meeting was as a citizen and not as a County Commissioner; however, this was a by invitation only meeting for community leaders.

Commissioner Arends, David Anderson, Commissioner Jibbens, and Karla Lems from the Carbon Dioxide Transport and Storage Advisory Committee (Committee) were in attendance as well. This Committee, as defined by the Chair, Commissioner Jibbens, is operating under the same rules and regulations as the Commission.

This meeting directly impacts the decisions that will need to be made by the Committee and later by the Commissioners and by no means should a quorum of board members have been in attendance. Lincoln County and its citizens deserve to be represented ethically by our local elected officials, it is out right and legally they have violated statute.



To Whom It May Concern,

On behalf of the Lincoln County Board of Commissioners, the following is a response to the Open Meeting Complaint filed by Wendi Hogan on December 5, 2023. As to the alleged violation committed by those members of the Carbon Dioxide Transport and Storage Advisory Committee, the Lincoln County Commission agrees that the allegation has no merit. There was no quorum present during the November 29, 2023, open house event hosted by NuGen Energy LLC.

As to the second allegation. While a quorum of County Commissioners was present, the open house event did not discuss public policy. Numerous other private citizens and community stakeholders were present. None of the commissioners discussed going to the event prior to their appearance. According to those in attendance, the open house event only provided information about current and future operations at the Nu Gen LLC facility and there was no formatted agenda. Further, one commissioner who was present has recused himself from all carbon pipeline related issues. Therefore, we also believe that there is no merit to the second allegation.
