 - Excessing Lodging for Alex Mayer out of state travel December 9, 2024 to December 13, 2024.

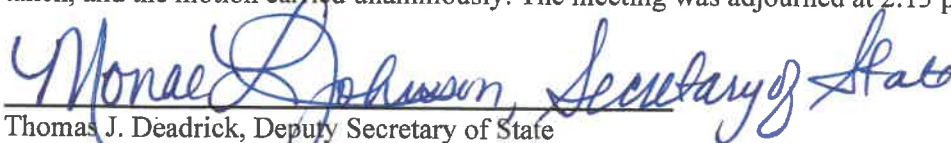
A motion was made by Jenna Latham and seconded by Leah Haugan to approve action item. A vote was taken, and the motion carried unanimously.
