Cronin moved and Neuharth seconded a motion to approve the out-of-state travel as presented (previously non-approved travel marked with an 'x'). Motion passed.

Funding requests:

The following funding requests were discussed:

- Anne Osborne from the National Wheat Foundation asked for Wheat 101 support. Johnson moved and Koeppe seconded a motion to provide \$1,000 to Wheat 101. Motion passed.
- Dr. Shyam Solanki asked for \$25,000 to purchase a software package for a microscope to support RNAi work on FHB. The instrument can also be used in root architecture and biological N fixation research. Gustafson said the SDCIA may be interested in funding half the amount. Cronin moved and Johnson seconded a motion to provide \$12,500 for the microscope project contingent on the SDCIA providing the other \$12,500. Motion passed.
- Dr. Whoi Cho presented a proposal to look at the economic effect of the SDSU wheat breeding programs. Kleinjan stated that the study would likely be ineffective without a USDA variety survey. No action taken.

CoAxium:

Kleinjan stated that he had discussed a CoAxium introgression agreement with Brad Erker from Colorado Wheat and Sunish Sehgal. Jorgensen asked if the SDWC would like to approve a support resolution for the agreement. The topic was tabled until the December meeting.
