CALL TO ORDER: The meeting was called to order by Chairman Glenn Blumhardt. The roll was called, and a quorum was present.

The meeting was streaming live on SD.net, a service of South Dakota Public Broadcasting.

BOARD MEMBERS PRESENT: Bob Ewing, Gregg Greenfield, Jessica Gruenwald, Gary Haag, Doyle Karpen, Rhett Miller, and Bob Morris participated in person. Chairman Glenn Blumhardt and Laurie Schultz participated via telephone.

BOARD MEMBERS ABSENT: None.

OTHERS PARTICIPATING: See attached attendance sheet.

APPROVE AGENDA: Motion by Karpen, seconded by Miller, to approve the agenda. The motion carried unanimously.

Chairman Blumhardt turned the gavel over to Vice Chairman Gregg Greenfield.

APPROVAL OF FEBRUARY 19, 2026, MEETING MINUTES: Motion by Ewing, seconded by Karpen, to approve the February 19, 2026, Board of Minerals and Environment meeting minutes. The motion carried unanimously.

TRANSFER OF SMALL SCALE MINE PERMIT 397 FROM WADE'S GOLD MILL, INC. TO ROBERT WADE: Eric Holm reported that Robert Wade requested transfer of Small Scale Mine Permit 397 from Wade's Gold Mill, Inc.

The general location of the permitted operation is approximately 10 miles southwest of Custer, SD. Under SDCL 45-6B-47 any mine permit can be transferred from one operator to another with the successor operator assuming all reclamation liability.

The complete transfer application form was submitted on February 2, 2026. The \$100 transfer fee was submitted on June 17, 2025.

The \$11,900 replacement surety was submitted on February 10, 2026, and the application was deemed complete on February 10, 2026

The department's recommendation to transfer the permit was prepared February 12, 2026, and was published in the Custer County Chronicle on March 4 and 11, 2026. The Affidavit of Publication was received March 16, 2026. The recommendation was also posted on the DANR public notice web page.

No petitions to intervene were received.

Under SDCL 45-6B-47, the board cannot deny a mine permit transfer unless the operation is not or cannot be brought into compliance with all applicable federal, state or local laws or the successor operator is in violation of state mining laws or mine permit conditions for any mining operation in the state.

The current mine permit and Robert Wade are in compliance with all federal, state, and local laws and regulations. Robert Wade also submitted a Certification of Applicant form and disclosed no violations.

Regarding the replacement surety, DANR currently holds a \$1,000 CD, and the US Forest Service holds \$4,500 in reclamation bonding for a total of \$5,500.

During staff review of the mine permit transfer application, DANR reviewed the reclamation surety and calculated a replacement surety amount of \$11,900. Since the maximum small scale reclamation bond amount has been increased from \$2,500 to \$38,500, the US Forest Service has agreed to allow DANR to hold the entire \$11,900 reclamation surety per the MOU between DANR and the Forest Service. Upon acceptance of the \$11,900 replacement surety by the board, the existing \$1,000 CD held by DANR will be released to Wade's Gold Mill Inc.

DANR recommended the board transfer Small Scale Mine Permit 397 and liability from Wade's Gold Mill, Inc. to Robert Wade; accept CD No. 6601016434, First Interstate Bank, Custer, SD, in the amount of \$11,900; and release CD No. 80138, First Interstate Bank, Hill City, SD in the amount of \$1,000.

Motion by Karpen, seconded by Miller to transfer Small Scale Mine Permit 397 and liability from Wade's Gold Mill, Inc. to Robert Wade; accept CD No. 6601016434, First Interstate Bank, Custer, SD, in the amount of \$11,900; and release CD No. 80138, First Interstate Bank, Hill City, SD in the amount of \$1,000. A roll call vote was taken, and the motion carried unanimously.

ANNUAL UPDATE OF POST-CLOSURE FINANCIAL ASSURANCE FOR HOMESTAKE MINING COMPANY, MINE PERMITS 332 AND 456 AND MINE PERMIT 445: Mr. Holm reported that in the May 18, 2006, Order regarding the post-closure financial assurance for Mine Permits 332 and 456, it states the financial assurance shall be automatically extended for periods of one year. At the time of each annual extension, the face value of the financial assurance shall

be adjusted to the bonding schedule set by the board in 2006 and updated in 2012, 2018, and 2023 during the five-year financial assurance reviews.

For 2026, the face value of the surety bond that serves as the post-closure financial assurance is required to be \$86,035,509. This is an increase from the \$84,000,056 amount which was submitted last year. For the increase, Homestake submitted a rider to Surety Bond No. 8233-63-10, Federal Insurance Company which increases the amount to the new face value. Federal Insurance is licensed in South Dakota and is on the US Department of Treasury list of approved surety companies. Ratings for the company from AM Best, Standard and Poor's, Moody's, and Fitch's are superior, very strong, high quality, and very high credit respectively. Outlooks are stable.

DANR recommended that the board accept the rider to Surety Bond No. 8233-63-10, Federal Insurance Company, increasing the post-closure financial assurance amount to \$86,035,509.

In the post-closure conditions for Mine Permit 445, which were approved by the board on January 21, 2016, it states the financial assurance shall be automatically extended for periods of one year. At the time of each annual extension, the face value of the financial assurance shall be adjusted to the bonding schedule set by the board in 2016 and updated in April 2022 as part of the five-year financial assurance review.

For 2026, the face value of the surety bond that serves as the post-closure financial assurance is required to be \$42,939,910. This is an increase from the \$41,773,222 amount, which was submitted last year. For the increase, Homestake Mining submitted a rider to Surety Bond No. 09177703, Fidelity & Deposit Company of Maryland and Zurich American Insurance Company, which increases the amount to the new face value. Both surety companies are licensed in South Dakota and are on the US Department of Treasury's list of approved surety companies. Ratings for both companies from AM Best, Standard and Poor's, Moody's, and Fitch's are superior, very strong, high quality, and very high credit respectively. Outlooks are stable.

As part of the January 21, 2016, conditions approved by the board, the department is required to do reviews of the Permit 445 post-closure bond beginning in 2021 and every five years thereafter in order to recalculate and update the bond. The next five-year review is scheduled for this year. The department will begin its review this spring, with a revised post-closure bond amount anticipated for board approval before the end of this year or early 2027.

DANR recommended that the board accept the rider to Surety Bond No. 09177703, Fidelity & Deposit Company of Maryland and Zurich American Insurance Company, increasing the post-closure financial assurance amount to \$42,939,910.

Motion by Karpen, seconded by Gruenwald, to accept the rider to Surety Bond No. 8233-63-10, Federal Insurance Company, increasing the post-closure financial assurance amount to \$86,035,509 for Homestake Mining Company Mine Permits 332 and 456, and to accept the rider to Surety Bond No. 09177703, Fidelity & Deposit Company of Maryland and Zurich American Insurance Company, increasing the post-closure financial assurance amount to \$42,939,910 for

Homestake Mining Company Mine Permit 445. A roll call vote was taken, and the motion carried unanimously.

MINING ISSUES CONSENT CALENDAR: Prior to the meeting the board received a copy of the consent calendar (see attachment).

Tom Cline with the Minerals, Mining, and Superfund Program was available for questions from the board. There were no questions.

Motion by Ewing, seconded by Miller, to approve the consent calendar, as presented. A roll call vote was taken, and the motion carried unanimously.

Mr. Blair and Mr. Naasz requested keeping the hearing venue in Pierre.

Motion by Gruenwald, seconded by Haag, to move the hearing to Hot Springs. A roll call vote was taken, and the motion carried with Gruenwald, Haag, Karpen, Schultz, and Greenfield voting aye, and Ewing, Miller, and Blumhardt voting no. Morris abstained.

#### Fall River County Ordinance

Motion by Miller, seconded by Ewing, to uphold Mr. Morris' ruling that the Fall River County Ordinance does not apply to the EXNI permit.

Substitute motion by Blumhardt, seconded by Gruenwald, to put the proceedings on hold until the board receives clarification from the courts as to the validity and the reach of the Fall River County Ordinance. A roll call vote was taken, and the motion failed with Gruenwald, Haag, and Blumhardt voting aye and Ewing, Karpen, Miller, Schultz, and Greenfield voting no. Morris abstained.

A roll call vote was taken on the original motion, and the motion carried with Ewing, Karpen, Miller, Schultz, and Greenfield voting aye and Gruenwald, Haag, and Blumhardt voting no. Morris abstained.

#### Applicant's Motion in Limine to Preclude Evidence Regarding Mining

The following provided statements against Mr. Morris' ruling regarding the applicant's motion: Dr. Liliias Jarding, Dr. Ben Sharp, Bruce Ellison, Elizabeth Lone Eagle, and Jean Roach.

Steve Blair and Matt Naasz provided statements in favor of Mr. Morris' ruling.

Motion by Miller, seconded by Gruenwald, to overrule Mr. Morris' ruling on the applicant's motion in limine. A roll call vote was taken and the motion carried with Gruenwald, Haag, Karpen, Miller, Schultz, Blumhardt, and Greenfield voting aye and Ewing voting no. Morris abstained.

#### Translation Services

The following provided statements in favor of overruling Mr. Morris' ruling to not allow translation services: Bruce Ellison, Jean Roach, Tonya Stands, Helen Red Feather, Bud Lone Eagle translating for Ms. Red Feather, and Elizabeth Lone Eagle.

Motion by Gruenwald, seconded by Miller, to overturn Mr. Morris' ruling and proceed as outlined in House Bill 1219, which was approved during the 2026 Legislature. A roll call vote was taken, and the motion carried with Ewing, Gruenwald, Haag, Karpen, Miller, Schultz, Blumhardt, and Greenfield voting aye. Morris abstained.

#### Electronic Service

The following provided statements in favor of allowing electronic service: Elizabeth Lone Eagle, Bruce Ellison. Mr. Naasz and Mr. Blair both noted that the statute and rules do not allow for electronic service.

Motion by Ewing, seconded by Miller, to uphold Mr. Morris' ruling to not allow electronic service. A roll call vote was taken, and the motion carried with Ewing, Gruenwald, Haag, Karpen, Miller, Schultz, Blumhardt, and Greenfield voting aye. Morris abstained.

Other Orders Issued by the Hearing Chair at the Request of the Parties or Intervenors

Elizabeth Lone Eagle, Bruce Ellison, Dr. Liliias Jarding, Tonya Stands, Taylor Gunhammer, and Steve Blair, requested that the board expand the length of the hearing. Mr. Naasz requested that the hearing remain at three days, as scheduled.

Motion by Karpen to move the hearing to April 13-15.

Substitute motion by Gruenwald, seconded by Haag, to move the hearing to April 13-17, 2026. A roll call vote was taken, and the motion carried with Ewing, Gruenwald, Haag, Schultz, and Greenfield voting aye and Karpen, Miller, and Blumhardt voting no. Morris abstained.
