Inquiry of the General Public present pursuant to State Law

Chairman Scull asked if any members of the general public wished to speak. No members of the general public were in attendance.

Board Member Conflict of Interest and Inquiry of Conflicts of Interest

Approval of the September 19, 2023 Annual Meeting Minutes

Avera Health Series 2024A Bond Issue

The bond issue is expected to be \$334,100,000. Mr. Templeton explained the new bonded money is being spent on these major projects:

Emergency Services & Clinic at Dawley campus; Women's and Children's Center at Avera McKennan campus; Curae Road on the South Louise Campus; New Gastroenterology Building on South Louise; 5th Floor completion of Avera Specialty Hospital on South Louise.

Mr. Kliewer explained the refundings of Series 2014 bonds, Series 2019A bonds, refinancing of a taxable US Bank loan and the possible purchasing of a portion of Series 2019B bonds. The expected savings are \$4.9 million.

Mr. Templeton reviewed the June 30, 2023 audited results as well as the December 31, 2023 year-to-date results. The S&P rating of AA- and the Fitch rating of AA- were discussed. Ms. Martin reviewed the Resolution on file at the Authority Office. Mr. Olson moved to approve the Resolution, seconded by Mr. Scott, and upon a voice vote, all ayes. Nays, none; abstain: none; motion carried.

Western Dakota Technical College "WDTC" Deed Release

WDTC has been experiencing declining enrollment and wants to build a student housing complex at an expected cost of \$14 to \$18 million. WDTC has deeded the SDHEFA 65 acres and would like approximately 4 acres released to build the Housing complex. Mr. Bonjour reviewed the Resolution on file at the Authority Office. Mr. Wiederhold moved to approve the Resolution, seconded by Mr. Fleck, and upon a voice vote, all ayes. Nays, none; abstain: none; motion carried.

Quad-State Meeting

Mr. Templeton invited members to attend the Quad-State meeting of four bonding authorities on June 16-18, 2024.

June 30, 2023 Audit and Auditor's Letters
