Minutes of the South Dakota Emergency Response Commission Meeting Conducted via Digital Dakota Network Joe Foss Building Mathew Training Center, Pierre, SD

OTHERS PRESENT: Macy Jo Peterson, Department of Agriculture and Natural Resources (DANR); Stephanie Silbernagel, DANR; Brenda Binegar, DANR; Rhett Howard, Office of Emergency Management; John Groen, Office of Homeland Security; Bre Bockstahler, Environmental Protection Agency (EPA) Region 8; Matt Mitravich, Cybersecurity & Infrastructure Security Agency (CISA) Region 8; and Dan Richards, Pipeline and Hazardous Materials Safety Administration (PHIMSA).

<u>CALL TO ORDER</u>: Chairman Dustin Willett announced the meeting was streaming live on SD.net, a service of South Dakota Public Broadcasting. He added that the meeting is being recorded and that the recording could be found online by going to the South Dakota Boards and Commissions portal. Chairman Willett called the meeting to order.

INTRODUCTIONS: Participants introduced themselves.

ROLL CALL: The roll was called, and a quorum was present.

<u>APPROVAL OF SEPTEMBER 12, 2023, SERC MEETING MINUTES</u>: Chairman Willet entertained a motion to approve the September 12, 2023, minutes. Motion by Kaitlyn Thomas, seconded by David Ackerman. Chairman Willet opened the floor for comments. No comments were made, and a roll call vote was taken. The motion passed unanimously.

<u>FEDERAL UPDATES</u>: Bre Bockstahler indicated she had no updates to the Safer Communities by Chemical Accident Prevention (SCCAP) rule revision to the Risk Management Program (RMP). Information about any changes may be available next month.

Regarding the Clean Water Act (CWA) Hazardous Substance Worst Case Discharge regulations, basically Facility Response Plans (FRP's) for chemical to water, expect to hear something in late winter or early spring.

The Western region State Emergency Response Commission (SERC) conference will be held February 21-22, 2024 in Clark County, Nevada. Chairman Willett indicated he planned to attend.

Chairman Willet opened the floor for public discussion. Trish Kindt had a question for Ms. Bockstahler regarding the EPA proposed livestock emissions reporting rule. Ms. Bockstahler stated she did not have a lot of information about that. She will be sending out an article about the issue in the upcoming newsletter. She further stated that EPA is looking for comments. She also indicated that EPA was proposing to take on some of the data management. Chairman Willet had a question for Ms. Kindt about how the state should comment. Ms. Kindt stated that DANR would prepare a letter as DANR also has a Livestock Service Program.

Matt Mitravich with CISA from Region 8 mentioned the ChemLock programs are voluntary, no-cost, secure your chemicals training. Training is provided in our region, is virtual or on-site, and includes premade tabletop training exercises. The training is open to use by any facility with any chemical. If anyone is interested, they can contact Mr. Mitravich.

CISA 8 provides a regional quarterly threat briefing webinar. The last training provided was a briefing on security and threats to water and wastewater. The next briefing is scheduled for March 6, 2024. The slide presentation regarding upcoming CISA events is attached to these minutes. Chairman Willet opened the floor for questions or comments for CISA. There were no comments or questions.

Mr. Mitravich provided an update on PHIMSA about a new hiring and restructuring the community liaison program on the Hazardous Material side. A new Chief Community Liaison, Clayton Hatfield, has been hired. Mr. Hatfield was a Community Liaison in the past and has been an investigator. He fills the void between the Community Liaison and the Field Outreach Coordinator, Mark Nichols.

CISA has also been working to provide information about grants and encourage people to apply for PHIMSA grants.

<u>REGIONAL HAZ MAT TEAM UPDATE – SOUTH DAKOTA OFFICE OF HOMELAND SECURITY</u>: John Groen with Department of Public Safety (DPS)/Homeland Security provided the update. Homeland Security recently updated the Haz Mat technician recertification task book to comply with NFPA 470. It was a great deal of work to check the Job Performance Requirements (JPRs) to make sure technicians are meeting the requirements every two years. Field force training took place in Rapid City in September.

Haz Cat operations training also took place in Rapid City in September. An LSU sampling course was held in Sioux Falls in November. In-house training has been ongoing in all departments. Representatives attended the Florida Search & Rescue Conference, and they took some search training while there. Chairman Willet opened the floor discussion. No comments were made.

LOCAL EMERGENCY PLANNING COMMITTEE (LEPC) GRANT APPLICATIONS: Trish Kindt gave an update on the LEPC grants. Currently, \$34,117.90 available for LEPC grants. Ms. Kindt recommended approval of grants for 31 LEPC's. A table listing the LEPC's that applied for grant funds was included in the board packet. This information was also posted on the South Dakota Boards and Commissions website at https://boardsandcommissions.sd.gov/bcuploads/Board%20Packet%20(5).pdf. The table lists information showing the applicants are active and meet grant requirements.

Macy Jo Petersen reviewed the grant applications. Spink County was not recommended for a grant because the LEPC didn't meet the requirements under SDCL 1-50-10. The LEPC did not meet the quarterly meeting requirement as they have not met since April 2023. The new Emergency Manager plans to resume having meetings, so the LEPC will be eligible for a grant next year.

The other 31 LEPC's met the criteria in SDCL 1-50-10. Grant amounts are calculated using the formula outlined in the law. The grant amounts are shown on the table the board received prior to the meeting.

Chairman Willet entertained a motion to approve 31 grants, with the exception of Spink County.

A motion was made by Tina Titze and seconded by Paul Merriman to approve grants for the following LEPCs: Bennett, Bon Homme, Brookings, Brown, Brule, Butte, Clark, Clay, Codington, Custer, Davison, Day, Edmunds, Fall River, Faulk, Grant, Hand/Buffalo, Hanson, Lake, Lawrence, Marshall, McPherson, Meade, Miner, Pennington, Perkins, Potter, Roberts, Tripp, War Hawk, and Yankton. A roll call vote was taken, and the motion carried with Ackerman, Canham, Merriman, Kindt, Kruger, Pitz, Titze, and Thomas voting aye. Chairman Willet abstained from voting because he is on the Pennington County LEPC. Becky Pitz, Davison County LEPC, and Dave Ackerman, McPherson LEPC, had planned to abstain but voted when their names were called.

HAZARDOUS MATERIALS EMERGENCY PLANNING (HMEP) GRANTS, TRAINING, AND PLANNING REPORT: Rhett Howard, Office of Emergency Management, provided the quarterly review of training and planning grant activities. The FFY 2022 grant was \$122,359.00, and \$101,494.09 has been spent. There is one grant pending for Aberdeen fire in the amount of \$1,689.25 for equipment, so the amount remaining is \$19,175.67. All grantees have completed activities for FFY 2022.

For the FFY 2023 grant, no activities have been completed to date. There was \$115,867.00 awarded for sub grantees to conduct HMEP activities. Since the last SERC meeting, Walworth County has replaced Moody County and will update its Haz Mat response plan. Moody County was not able to participate this year but may do so in a future grant year.

For the FFY 2019-2021 grants, a 90-day extension was granted. Approximately \$44,000 was left over due to COVID causing activities to be cancelled.
