CALL TO ORDER: The meeting was called to order by Chairman Glenn Blumhardt. The roll was called, and a quorum was present.

The meeting was streaming live on SD.net, a service of South Dakota Public Broadcasting.

APPROVE AGENDA: Motion by Ewing, seconded by Miller, to approve the agenda. The motion carried unanimously.

APPROVAL OF MINUTES FROM March 18, 2026, MEETING: Motion by Miller, seconded by Ewing, to approve the minutes of the March 18, 2026, Board of Minerals and Environment meeting. A roll call vote was taken, and the motion carried unanimously.

MINING ISSUES CONSENT CALENDAR: Prior to the meeting the board received a copy of the consent calendar (see attachment).

Michael Evans with the Minerals, Mining, and Superfund Program was available for questions from the board. There were no questions.

Motion by Morris, seconded by Schultz, to approve the consent calendar, as presented. A roll call vote was taken, and the motion carried unanimously.

TRANSFER OF EXPLORATION NOTICE OF INTENT (EXNI) 437 FROM MARK HUGHES TO HARVEY BLAND: Roberta Hudson reported that Harvey Bland requested transfer of EXNI 437 from Mark Hughes. EXNI 437 is generally located approximately eight miles west of Custer, SD.

Under SDCL 45-6C-53 any EXNI can be transferred from one operator to another with the successor operator assuming all reclamation liability.

DANR received the transfer application and fee on February 23, 2026. Mr. Bland supplied his replacement reclamation bond on March 16, 2026. At that time, staff determined the application to be complete.

Mr. Bland was required to publish a notice of transfer in a local paper, which he did on April 1, 2026, in the Custer County Chronicle. DANR received the Affidavit of Publication on April 7, 2026.

Under SDCL 45-6C-53, the board cannot deny an EXNI transfer unless the operation is not or cannot be brought into compliance with all applicable federal, state, or local laws, or the successor operator is in violation of state statutes, rules, notice restrictions, mining permit conditions, or requirements with respect to any exploration or mining operation in the state.

Ms. Hudson stated that the current EXNI and Mr. Bland are in compliance with all federal, state and local laws and regulations.

Staff recommended the board approve the transfer of EXNI 437 from Mark Hughes to Harvey Bland, release Surety Bond No. 810009342, Atlantic Specialty Insurance Company in the amount of \$4,469, and accept replacement CD No. 661016758, First Interstate Bank in the amount of \$4,469.

Motion by Morris, seconded by Ewing, to transfer EXNI 437 from Mark Hughes to Harvey Bland, release Surety Bond No. 810009342, Atlantic Specialty Insurance Company in the amount of \$4,469, and accept replacement CD No. 661016758, First Interstate Bank in the amount of \$4,469. A roll call vote was taken, and the motion carried unanimously.
