

3/17/2025	<p>Participant received a stairlift to access the upstairs of her home where the main bathroom and shower are located. She had not been able to access the upstairs for about 9 months due to weakness and fear of falling. She uses a walker to ambulate and prior to getting weaker, held on to a hand rail going up and scooted down on her bottom to get downstairs. This stairlift was provided giving her access and security going upstairs to the main bathroom in the home where she can now shower again and the fear of falling is no longer a problem.</p>
