BIE/ESSA Waiver/DOE: Sherry Johnson gave an update. The BIE says to follow state, it has been published and for comments, will go in effect 2021. BIE and tribal schools will have option to take BIE assessment this next year, more than assessment, if they have option to go with State accountability, they must follow state standards.

The DOE strategic plan: Joe Moran shared that the research groups, REL and Region 11 Comprehensive Center, form a network of community allies for all native American learners and communities.

Native American Achievement school Grants: (to be continued) It will be added to the next agenda. Dr. Aguilar-Black Bear, at DOE is assisting Joe Moran with the final report.
