





#### CONGRESSIONAL SCHEDULE

- ➤ Ist Session of the 119th Congress will adjourn sometime this fall
- Congress is on August Recess until early September
- > 2<sup>nd</sup> Session of the Congress convenes in January 2026
- Mid-Term Elections are on November 3, 2026 – all House members and 1/3 of the Senate

# DELAYED EDUCATION FUNDS RELEASED

- Department of Education has released delayed education funds to states
- Released \$6.8 billion State ESEA funds after significant pushback from some Senators
- ➤ These Elementary and Secondary Education Act (ESEA) funds had been delayed since July 1, 2025
- > These include:
  - ➤ Title I-C for migrant education (\$375 million)
  - ➤ Title II-A for professional development (\$2.2 billion)
  - > Title III-A for English-learner services (\$890 million)
  - > Title IV-A for academic enrichment (\$1.3 billion) and
  - > Title IV-B for before- and after-school programs (\$1.4 billion)

#### FFY 2026 APPROPRIATIONS PROCESS

- > President released his Budget Request for FFY 2026 in 2 steps in the spring
- ➤ House postponed markup right before August recess until early September
- Senate Appropriations Committee completed markup of some bills including one that funds health/human services, education, and labor programs
- The bill, passed by a bipartisan vote of 26-3, provides \$197 billion for programs October 1, 2025, through September 30, 2026
- Next Steps
  - Senate bill goes to Senate floor
  - ➤ House bill clears committee and goes to House floor
  - > Both House and Senate need to agree to same funding levels
  - President signs bill into law
- ➤ Deadline September 30<sup>th</sup> or Continuing Resolution (CR) or government shut down

# DEPARTMENT OF EDUCATION IDEA BUDGET REQUEST FROM PRESIDENT

- The budget documentation indicates this request "reflects an agency that is responsibly winding down."
- > Requested a consolidation of seven of the eight programs under IDEA.
- Six programs, zero funded, would be consolidated into Part B State Grant Program
- Part C, the Early Intervention program would continue to be separately funded at \$540 million, a freeze at the levels for both FFY 2024 and 2025.

# PROPOSAL FOR CONSOLIDATION OF IDEA PROGRAMS

Six IDEA Part D programs would be consolidated under the Part B Section 611 State Grant program.

- Preschool 619 program, funded at \$420 million in FFY 2025,
- State Personnel Development funded at \$38.6 million in FFY 2025,
- Technical Assistance and Dissemination funded at \$39.4 million in FFY 2025,
- Personnel Preparation funded at \$115 million in FFY 2025,
- Parent Information Centers funded at \$33.2 million, in FFY 2025
- Educational Technology, Media, and Materials funded at \$31.4 million in FFY 2025.

#### SENATE COMMITTEE BILL

- > Passed full Appropriations Committee by a bipartisan vote of 26-3
- The bill also provides \$15.22 billion, an increase of \$50 million over fiscal year 2025, for all three IDEA Special Education State formula grant programs and retains each as a separate program.
- Each of the programs under Part D are also maintained as separate programs with funding recommended at FFY 2025 level
- The bill does not support elimination of Dept of Education and would maintain IDEA programs with the Department of Education.
- Includes language that the bill prohibits any transfer of these funds and their programs to other agencies and requires ED to maintain sufficient staffing "to fulfill its statutory responsibilities."

#### OSEP MENTIONED

- The Report accompanying the bill specifically mentions the Office of Special Education Programs (OSEP) that administers and monitors IDEA law
- The Committee notes the important role that the Office of Special Education Programs [OSEP] plays in ensuring States' compliance with IDEA and requests an update in the fiscal year 2027 congressional justification on OSEP's IDEA monitoring and technical assistance support efforts maintained by funding provided in this act."
- According to the summary of the bill released by the Committee, the bill includes language that programs and activities funded in this bill should be made in a timely manner
- The bill also includes a requirement that the Department of Education make formula grants available to states and districts on time.

#### RECONCILIATION BILL PASSED

- > July 4th the President held a signing ceremony for the final reconciliation bill
- > H.R. I was passed by very small margins by both the House and the Senate
- Senate passed their version of the bill after much deliberation, a 16-hour reading of the entire 940-page bill by Senate clerks, and a more than 20-hour Senate "vote-a-rama" during which both parties offered amendments
- Final bill passed the Senate with the Vice-President breaking the 50/50 tie
- The final Senate bill was significantly different than the House bill passed before Memorial Day recess and sent to the Senate for consideration.
- The new Senate bill went to the House for consideration several days before the July 4<sup>th</sup> events. If the House had changed the bill again, it would have had to return to the Senate for passage.
- > The House passed the bill by a vote of 218 to 214

# RECONCILIATION PROVISIONS

- Dates of implementation for various provisions of the new law will vary over the next several years including some of the Medicaid and SNAP cuts being effective in 2028
- Permanent extension of the \$4 trillion in tax cuts and temporary elimination of taxes on tips and overtime, which brings the size of the tax cut in the bill to about \$4.5 trillion
- > \$1 trillion in Medicaid cuts, including work reporting requirements as a condition for Medicaid eligibility for individuals ages 19-64
- State restriction on imposing health care "provider taxes" to help fund state matching for Medicaid reimbursement
- About \$186 billion in cuts over ten years from SNAP which includes a required fiscal contribution from some states, a state requirement to cover 75 percent of the cost to administer the program and expanded work requirements

# ADDITIONAL PROVISIONS IN THE NEW LAW

- A new federal education voucher initiative;
- ➤ A new \$50 billion fund to support rural hospitals beginning in in 2028 and lasting five years;
- Allocation of \$350 billion for border security, including new ICE hires and migrant detention beds, and \$25 billion for missile defense;
- \$46.5 billion toward completing the border wall;
- Increase of the debt ceiling to \$5 Trillion
- Exclusion of children from accessing the Child Tax Credit that live in families in which one or both parents do not have Social Security Numbers;








# 12.1 Child Count Demographics






# Child count by Demographics






# 12.1.24 Child Count by Region



#### Child Count Trend




