Department of Education Updates:

- Linda Turner discussed the state determinations. The federal Office of Special Education Programs issues
 annual state determinations based on the current years State Performance Plan data submitted for FFY
 23. The state determinations were based on data from the 2023-2024 school year, with some lag data
 from 2022-2023. South Dakota fell within the Needs Assistance category for the second year.
- Wendy Trujillo gave an overview of the Dispute Resolution 2024-25 Results:
 *The IDEA requires state educational agencies (SEA) to have procedures in plate to offer dispute resolution when a parent or school district disagree over special education services provided under IDEA. SEAs are required to offer mediation, written state complaint (investigations) and Due Process Hearing and Expedited Due Process Hearing. Some other options in South Dakota are IEP Facilitation and the SD Parent Connection Navigator Program.
- The interagency agreements are current and no updates have been made.
- Wendy Trujillo reviewed the list of Department of Education professional learning opportunities.
