Commissioner Christopher Funk disclosed a potential conflict of interest with the Lake Area Technical Institute (LATI) funding request due to his employer, South Dakota State University (SDSU), providing aeronautical education services that may be similar to services provided by LATI. Funk previously filed a waiver request and disclosure relating to his employment with SDSU. Funk will recuse himself from the discussion and the vote relating to the Lake Area Technical Institute funding request on the agenda.

Karla Engle, Office of Legal Counsel, reminded Commission members to submit their annual conflict of interest disclosures before the July meeting for Commission consideration.

Odenbach requested a correction to the May 28, 2019, Commission meeting minutes regarding the purchasing of the plastic airport marker cones total price.

Odenbach asked for a motion to approve the minutes of May 28, 2019, Commission meeting with the correction included in the motion.

A MOTION WAS MADE by Huggins and seconded by Funk to approve the May 28, 2019, Aeronautics Commission meeting minutes with the requested correction to the plastic airport marker cones total price. All present voted aye by roll call vote. The motion carried.

Funk recused himself from the discussion and vote regarding this consideration because of a possible conflict of interest.

Becker introduced Greg Klein of LATI to present to the Commission the details of the request for \$30,000.00 in funding for LATI's new two-year Professional Pilot program that will start in the fall of 2019. The funding would be used to update LATI's aircraft instrument panel. The aircraft is a Cessna 172 and it was donated by a LATI alumnus. Klein also shared how the new program is being budgeted and LATI's current and future enrollment plans.

Odenbach suggested the Commission table the request for consideration of funding until the July Commission meeting to allow the Commission time to consider what funds may still be available outside of funds obligated for Airport Improvement Project funding cost shares.

A MOTION WAS MADE by Huggins and seconded by Nelson to table the consideration of funding for the LATI aviation program until the next regular meeting of the Commission. All present voted aye by roll call vote, except Funk who abstained from the discussion and vote. The motion carried.
