Chairman Larry Nelson called the meeting of the South Dakota Transportation Commission (the “Commission”) to order at 1:02 p.m. CDT. A roll call was taken and a quorum was determined.

Nelson opened the floor to the Commissioners to disclose potential conflicts of interest. Engle discussed the legal considerations that apply to potential conflicts of interest in a quasi-judicial setting.

Commissioner Mike Vehle disclosed that he worked with a woman named Audrey Kinsella in 1985 on a project called Leadership Mitchell but was unsure whether Audrey Kinsella had any relationship with Dena Kinsella. Dena Kinsella said she didn’t know anyone by that name. Vehle indicated he did not believe this matter was a disqualifying conflict.

A MOTION WAS MADE by Roby and seconded by Zander that Commissioner Vehle’s disclosure of a working relationship with Audrey Kinsella was not a conflict of interest that requires recusal from the administrative hearing involving Ms. Kinsella. All present voted aye by roll call vote. The motion carried.

Vehle also disclosed that he and his partner purchased furnishings from a decorator and then had dinner with the decorator and her husband, Robert Burns of Minneapolis, Minnesota approximately five years ago. Patrick Burns, counsel for Dena Kinsella, stated Robert Burns is his father and the decorator is his stepmother. Vehle indicated he did not believe this was a disqualifying conflict.

A MOTION WAS MADE by Rosenboom and seconded by Cull that this disclosure by Commissioner Vehle was not a conflict of interest that requires a recusal from the administrative hearing involving Ms. Kinsella. All present voted aye by roll call vote. The motion carried.

No other conflicts were disclosed, and no waivers were requested.

Karla Engle, Office of Legal Counsel, announced the hearing on the application for authorization to exercise eminent domain by Rapid City, Pierre & Easter Railroad Inc. (RCP&E). Engle introduced Judge David Gienapp as the hearing examiner who would preside over the hearing and prepare a recommended decision for consideration by the Commission.

Steven Williams and Jeffery Collins appeared as legal counsel for RCP&E. Patrick Burns appeared as legal counsel for Dena Kinsella. As part of Rod Wiseman, general manager of RCP&E, testified in favor of RCPE's application for authorization to exercise eminent domain over real property owned by Dena Kinsella for the purpose of accessing a railroad bridge and staging materials.

Dena Kinsella testified in opposition to RCPE's application. Tom Kinsella offered testimony relating to RCP&E's application. Rod Wiseman offered additional testimony relating to RCP&E's application.

Steven Williams presented closing argument in favor of RCP&E's application and Patrick Burns presented closing argument in opposition to the application. The hearing was concluded. The parties and witnesses to the hearing, and their counsel, left the meeting.

Judge Gienapp discussed procedural aspects of the hearing with the Commission.

Nelson asked for a motion for the Board to enter into Executive Session.

A MOTION WAS MADE by Zander and seconded by Rosenboom to enter into executive session pursuant to SDCL 1-25-2(3) for the purpose of consulting with legal counsel or reviewing communications from legal counsel about proposed or pending litigation or contractual matters. All present voted aye by voice vote. The motion carried.

Executive session began at 5:00 p.m. CDT.

Chairman Larry Nelson called the meeting of the Commission back to order at 9:02 a.m. CDT. A roll call was taken and a quorum was determined.

Nelson opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to the South Dakota Codified Law (SDCL) chapters 3 – 23.

No conflicts of interest were disclosed, and no waivers were requested.

Nelson asked for a motion to approve the June 10, 2021 Commission meeting minutes.

A MOTION WAS MADE by Roby and seconded by Fouberg to approve the June 10, 2021 Commission meeting minutes. All present voted by voice vote. The motion carried.

Secretary Joel Jundt provided the Secretary's Report. Jundt presented the following to the Commission:

1. Increase in State highway funds compared to last year
2. Update on Federal Reauthorization status
3. Visit to Yankton as part of the September *On the Road* meeting to include a visit to the Meridian Bridge.

Craig Smith, Division of Operations Director, presented the following Construction Change Orders (CCOs) to the Commission:

Construction change orders completed in May contain an increase of approximately \$1,589,241.95.

Over the past 12 months, the overall contract increase is 2.93%.

The following projects have a Construction Change Order (CCO) amounting to a contract change more than \$50,000.

The Department review asphalt concrete mix design contained an asphalt binder content target lower than estimated in the plans.

The Department increased the contract quantity of asphalt concrete to match the quantity used during construction. The quantity of material salvaged and stockpiled for future use was more than estimated in the plans.

This CCO reduced those estimated quantities to the actual quantity used to construct the temporary diversion.

As a result, addition virgin granular material was furnished by the contract resulting in and increase to the granular material furnish item. The overall change was an increase in cost.

The queue detection system will alert the traveling public of traffic backups in advance allowing the traveling public to choose an alternate route or to be prepared for traffic backups.

Smith presented for Commission consideration approval of access control relinquishment for existing access approaches located on the north side of SD34 east of Washington Ave South, in Madison, Lake County. Permits were issued by the Department to allow the construction of the subject access points, but the access requests were never properly processed to request an approved break in the control of access. The relinquishment would simply allow for the approval of a break for the access location that exists today.

A MOTION WAS MADE by Fouberg and seconded by Roby to approve the request to relinquish the identified control of access located on the north side of SD34 east of Washington Ave South in the City of Madison. All present voted aye by voice vote. The motion carried.

Tammy Williams, Program Manager for the Office of Administration presented the 2022 Bridge Improvement Grant (BIG) Procedures and the Five-Year County Highway and Bridge Improvement Plan documents for Commission consideration. Williams indicated the following changes were made:

Notable changes in 2021 BIG Procedures

- Section II Definitions - Removed the definition of Sufficiency Rating – the use of the numeric value representing the structures sufficiency to remain in service has been phased out and replaced with a general condition rating of good, fair, and poor..
- Section III Funding Responsibilities – at end of first paragraph added a clarifying statement to note that any requests for deviations from this procedure must be made with application and will be considered with DOT’s recommendation for award..
- Section VI Scoring Criteria –
 - 1.a. Posting score changed from 27 to 28 points with added point placed on structures whose rating is greater than 39.9% below the maximum legal load..
 - 1.g. Sufficiency Rating – deleted from scoring calculation.
- Section VII Project Development Requirements Following Grant Award – In Section C.2.e., removed requirement that the Department will review and offer comments on shop plans of prefabricated products; this review will be the responsibility of the Engineer of Record.
- All other changes were small grammatical corrections, year references for the current grant cycle, file transfer location changes, and updates to web links.

Notable changes in the 2022-2026 5-Year County Highway and Bridge Improvement Plan Guide

- Section B Definitions - Removed the definition of Sufficiency Rating – the use of the numeric value representing the structures sufficiency to remain in service has been phased out and replaced with a general condition rating of good, fair, and poor.

Brad Staegoh of Ulteig presented information to the Commission about a funding shortfall for a BIG Preliminary Engineering grant received by Union County. Staegoh indicated the county will be seeking additional funding for the project.
