Vice-chairman Chris Frick called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CT. A roll call was taken and a quorum was present.

Frick opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3 – 23.

Karla Engle, Office of Legal Counsel, acknowledged the Board's receipt of three annual disclosures submitted by Austin Simons, Jaf Karim, and Larry Nelson. The disclosures are attached to these minutes as **ATTACHMENT A - C**. The disclosures will be filed as required by law.

No other members of the Commission disclosed a conflict or requested a waiver.

Frick asked for a motion to approve the June 23, 2026 Commission meeting minutes.

A MOTION WAS MADE by Jensen and seconded by Vehle to approve the June 23, 2026 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Frick opened the floor to public input.

No members of the public addressed the Commission or offered any input.

Karla Engle, Office of Legal Counsel, requested the Commission set a hearing date of August 27, 2026, to consider amendments to Administrative Rule of South Dakota (ARSD) 70:01:02:62 – Union County speed zone rule.

A MOTION WAS MADE by Karim and seconded by Vallery to set the administrative hearing date for August 27, 2026. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2026 – 7.1 was adopted.

Engle then addressed the Commission regarding the annual acknowledgment of review of the open meeting brochure provided by the Attorney General. The updated 2026 Open Meeting brochure authored by the Attorney General had been provided to the Commission as Attachment #4 for the Commission's review.

All present acknowledged reviewing these open meeting materials by roll call.

Secretary Jundt presented the following items to the Commission in his Secretary's Report:

- **Federal Funding:** House Transportation and Infrastructure (T&I) Chair Sam Graves was quoted on Wednesday July 15, agreeing that surface transportation reauthorization legislation developed by the T&I Committee would not be considered on the floor of the House until after the August recess. There are not many days that either the House or the Senate will be in session prior to September 30, 2026. It is likely that an extension of Infrastructure Investment and Jobs Act (IIJA) will be the vehicle needed to be passed to maintain the highway program. For FY2027 appropriations, on Monday, July 20, the House of Representatives passed a continuing resolution (CR) to keep the Federal Government funded at levels equal to the FY2026 levels. This CR will run through December 4, 2026. The bill now goes to the Senate.
- **2019 Highway Infrastructure Program (HIP):** In FY2019, the Department of Transportation (the "Department") received HIP funding through the federal appropriations act to be used for bridges in each state. At that time, the Commission decided to split those funds with our local government agencies (LGA's) (\$17.313 million of the \$20.786 total went to LGA's) based on deck area in poor condition. Also, the Commission authorized the Department to provide these funds as state funds in lieu of federal aid projects. Those funds were expected to be used on local government structures by FY2021. Agreements were made, but due to the short timeframe to expend funds, the agreements were extended until December 31, 2025. Six local governments have not expended their full allocation (\$286, 971) and two have requested an additional extension (Jackson County - \$173,037 & City of Egan \$5,378 for a total of roughly \$178,400). We

have corresponded with these local governments and informed them that they will have until December 31, 2027 to expend the funds or they will be billed for reimbursement.

- **Better Utilizing Investments to Leverage Development (BUILD) Grant:** The Department was awarded a BUILD Grant Award for South Veterans Parkway of \$24 million which will be shared with the City of Sioux Falls (\$2.2 million). This is discretionary funding will supplement the Department's federal formula funding.
- **State:** We have issued several addenda on the Platte / Winner Bridge. One of these addenda required that the Department move the letting date to August 5, 2026.
- **SD1806 Slide/ Darrell Smith Property:** The work on Mr. Smith's property was completed in late May / early June. Due to reaching seasonal limitations on placing permanent seeding, the Mobridge Area staff met with Mr. Smith and it was agreed that a cover crop seed should be placed until permanent seeding can be completed later in August. Cover crop has been placed and final seeding will be done in August.

Although there was some contractor-furnished borrow material needed to complete the project, it was minimal. The contractor-furnished borrow material did come from the Smith's property. The Department doesn't have a measured quantity yet nor any details on the agreement between the contractor and Mr. Smith.

Ryan Johnson, Office of Operations Support, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in June contain a decrease of \$2,426,974.28. Over the past 12 months, the total change to the original contract amounts has increased by 1.51%. The following projects have a CCO with a change of more than \$100,000 or a change of more than 25.0% to the contract.

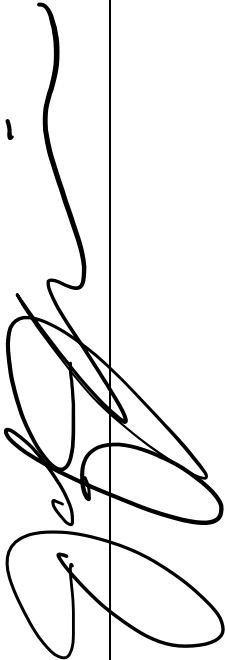
