Chairman Simons called the meeting of the South Dakota Transportation Commission (the “Commission”) to order at 9:00 a.m. CT. A roll call was taken and a quorum was present.

Simons opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3 – 23.

No members of the Commission disclosed a conflict or requested a waiver.

Simons asked for a motion to approve the August 13, 2026 Commission meeting minutes.

A MOTION WAS MADE by Vehle and seconded by Rosenboom to approve the August 13, 2026 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Simons opened the floor to public input.

No members of the public addressed the Commission or offered any input.

Karla Engle, Office of Legal Counsel, announced a public hearing on the Commission's consideration of the proposed amendments to Administrative Rules of South Dakota (ARSD) 70:01:02:62 – Union County speed zone rule.

Engle explained the rule adoption process that had been followed to date for the amendments to the rules. She discussed the purpose and effect of the rule changes. Engle reported that the changes required by Legislative Research Council had been incorporated into the proposed rules. Engle also reported that no written comments on the rule changes had been timely received.

Simons asked for public testimony in favor of or opposed to the proposed rule amendments. No members of the public offered testimony in support of or in opposition to the rule changes.

A MOTION WAS MADE by Jensen and seconded by Vallery to approve the proposed amendments to ARSD 70:01:02:62 – Union County speed zone rule. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2025 – 8.2 was adopted.

Secretary Jundt presented the following items to the Commission in his Secretary's Report:

- He updated the Commission on the status of federal highway funding.
- He provided an update on speed limit compliance on Highway 12 east of Aberdeen. Those results show good compliance with the speed limit.
- He reminded the Commission of the upcoming On-the-Road meeting in Sioux Falls on September 22 and 23.

Ryan Johnson, Office of Operations Support, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in July contain a decrease of \$2,478,472.32. Over the past 12 months, the total change to the original contract amounts has increased by 1.39%.

The following projects have a CCO with a change of more than \$100,000 or a change of more than 25.0% to the contract.

Explanation of Change on CCO No. 6: This increase is the result of SDDOT adjusting contract quantities to match as built quantities and compensating the contractor for extra work not included in the plans to fill in gore areas with excavation, base course, and asphalt concrete .

2. Project: IM-B-CR 2292(101)3, Minnehaha County, PCN 05HN
Location: I-229 Exit 4 (Cliff Avenue)
Contractor: T & R Contracting, Inc.
Type of Work: Grading, PCC surfacing, structures

Original Contract Amount: \$ 48,026,131.12

% Change on CCO No. 11: 0.4%
Net Change to Date: \$ 1,142,258.04

Explanation of Change on CCO No. 11: This increase is the result of SDDOT adjusting the contract to change a cantilever sign structure to a double beam sign bridge for future project considerations. The new sign would accommodate the existing needs and a planned lane expansion in the area.

Explanation of Change on CCO No. 4: This increase is the result of SDDOT adjusting contract quantities to match as built quantities and extra work to place additional asphalt at selected locations for a smoother surface.

Johnson then presented to the Commission the Division 1 revisions for the proposed October 7, 2026 Electronic Standard Specifications for Roads and Bridges. Johnson provided an explanation of the significant modifications.

A MOTION WAS MADE by Vehle and seconded by Vallery to approve the revisions made to Division I of the South Dakota Standard Specifications for Road and Bridges, which will be effective October 7, 2026. All present voted aye by roll call vote. The motion carried.

Jack Dokken, Program Manager for the Office of Air, Rail and Transit, presented for Commission consideration the request to approve the current recommended scoring procedures for funding public transit with state funds. The procedures include consideration of ridership data from the previous Federal Fiscal Years(FFY) to ensure a fair and performance-based allocation of funds as follows:

A MOTION WAS MADE by Vehle and seconded by Roseboom to approve bid #1. All present voted aye by roll call vote. The motion carried.

John Keyes, Program Manager for the Office of Right of Way, presented the following items for Commission consideration.

1. Request Transportation Commission approval to transfer by resolution and deed to the City of Pringle, Custer County, the following property acquired for highway right of way:

Lot B in H.E.S. 45 of the SW1/4 of Section 13 and the NW1/4 of Section 24, all in Township 5 South, Range 4 East of the B.H.M., Custer County, South Dakota. (contains 0.10 acre)

The above property is located on the east side of Pringle along Northern Street. This transfer is intended to clarify title to the City of Pringle's Water Station Tract. The Department's Rapid City Region and Custer Area advised the above property is no longer needed for highway purposes and recommend transfer.

A MOTION WAS MADE by Jensen and seconded by Roby to approve the transfer in Custer County. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2026-8.3 was adopted.

2. Request Transportation Commission approval to abandon by resolution the following property acquired for highway right of way:

Lot B in a portion of Lot H1 in Government Lot 6 and Relicted Land of Government Lot 6 of Section 28, Township 5 North, Range 31 East of the B.H.M. in Fort Pierre, Stanley County, South Dakota. (contains 0.09 acre)

The above property is located on the north side of US Hwy 14/83 in Ft. Pierre near the Missouri River bridge. The Department's Pierre Region and Pierre Area advise the above property is no longer needed for highway purposes and recommend abandonment.

A MOTION WAS MADE by Vallery and seconded by Vehle to approve the abandonment in Stanley County. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2026-8.4 was adopted.

Mark Leiferman, Program Manager for the Office of Project Development presented the following Statewide Transportation Improvement Program (STIP) revisions for the Commission's information:

REV 26 – SC - 018 This revision removed “AC Surfacing” and added “PCC Surfacing” to the work description to a FY2026 City of Lemmon street improvement project on 1st St E (Railway St) - Fm Main St E 0.1 to 1st Ave E; 1st Ave E - Fm 1st St E S 0.1 to 2nd St E; 2nd St E - Fm Main St E 0.2 to 2nd Ave E in Perkins County in the Rapid City Region. (This project was added to the 2026-2029 STIP per REV 26-015 in February 2026.)

FY 2026 No Change

Mike Behm, Director of Planning & Engineering, presented for Commission consideration the 2027-2030 STIP, Sioux Falls Metropolitan Planning Organization (MPO) Transportation Improvement Program (TIP), Sioux City MPO TIP, Rapid City MPO TIP, and Transit Improvement Program.

A MOTION WAS MADE by Rosenboom and seconded by Vehle to approve the 2027 – 20230 STIP, Sioux Falls MPO TIP, Sioux City MPO TIP, Rapid City MPO TIP, and Transit Improvement Program. All present voted aye by roll call vote. The motion carried.

Kinniburgh distributed the revised version of Attachment #11, attached to these minutes as **ATTACHMENT A**, which contains the modified BIG scores and rankings of the 2026 Local Federal Bridge Program Preliminary Engineering applications. He discussed the scoring process and explained there are two categories of applications: federal aid routes (on-system) and non-federal aid routes (off-system). He shared the Department's recommendation to award grants to the two (2) top-ranked on-system applications for Yankton County and Gregory County, and the ten (10) top-ranked off-system applications for the City of Gary (2 projects), Roberts County, Spink County, Grant County (2 projects), Meade County, Codington County, Deuel County, and McCook County, as shown on the revised version of Attachment #11. If approved, the estimated total award would be approximately \$2.08 million. Kinniburgh also asked that these twelve preliminary engineering projects be added to the 2027-2030 STIP as a “Staff Recommended Change” for 2027.

A MOTION WAS MADE by Jensen and seconded by Vallery to award 2026 Local Federal Bridge Program Preliminary Engineering grants and add these projects to the STIP as recommended by the Department. All present voted aye by roll call vote. The motion carried.

Doug Kinniburgh, Office of Administration, presented for Commission consideration the 2027 Preliminary Engineering Bridge Improvement Grant (BIG) applications. He discussed the process and shared that the Department recommends awarding grants to the twenty-four (24) top-ranked applications as shown on the revised version of Attachment #10 that is attached to these minutes as **ATTACHMENT B**, consisting of awards to the following Counties: Union (2 projects), Butte (2 projects),

Lincoln (4 projects), Roberts (2 projects), Moody, Grant (2 projects), Deuel, Beadle (2 projects), Yankton, Perkins, Hughes (2 projects), Codington (2 projects), and Minnehaha (2 projects) for a total grant award of \$1.39 million. Kinniburgh also asked that these projects be added to the current STIP by revision for 2026.

A MOTION WAS MADE by Vehle and seconded by Roby to award the 2027 Preliminary Engineering Bridge Improvement Grants and add these projects to the STIP as recommended by the Department. All present voted aye by roll call vote. The motion carried.

With no further business to come before the Commission, Chairman Simons declared the meeting adjourned at 10:23 a.m. CT.
