Chairman Eric Odenbach called the meeting of the South Dakota Aeronautics Commission (the “Commission”) to order at 2:00 p.m. CT. Roll call was taken and a quorum was determined.

Odenbach opened the floor to the Commission to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) Chapter 3 – 23.

No commissioners disclosed a conflict of interest nor requested a waiver.

Odenbach asked for a motion to approve the April 18, 2024 Commission meeting minutes.

A MOTION WAS MADE by Huggins and seconded by Taylor to approve the April 18, 2024 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Odenbach opened the floor to public comment.

No members of the public addressed the Commission or offered input.

Secretary Jundt presented the Secretary's Report. He shared that Congress has passed and President Biden has signed the new FAA Reauthorization bill. He noted that funding apportionments for essential airports increased by 111%, service grants for small airports increased by 50%, and the funding for Airport Improvement Program (AIP) grants increased to \$4 billion.

Jundt presented to the Commission the draft of the South Dakota Airport Terminal Funding Application for the Commission's review. He shared that the Letter of Intent (LOI) for SB144 was approved by the Joint Committee on Appropriations on May 21, 2024, and recommended the following timeline for action:

1. Applications due to the Commission on June 10, 2024
2. Applications are heard by the Commission on June 20, 2024, at the Commission meeting
3. Decisions on which applications to fund are made on July 18, 2024, at the Commission meeting

A MOTION WAS MADE by Taylor and seconded by Funk to move forward as recommended by the Secretary. All present voted aye by roll call vote. The motion carried.
