Chairman Jaf Karim called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CDT. A roll call was taken and a quorum was determined.

Karim opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3 - 23.

Karim acknowledged the receipt of annual conflict of interest disclosures from Commissioners Nelson, Roby, and Karim which were included as Attachments #1A-C in the Commission packet and are attached to these minutes. No other conflicts of interest were disclosed and no new waivers were requested.

Karim asked for a motion to approve the June 29, 2023 Commission meeting minutes.

A MOTION WAS MADE by Roby and seconded by Vehle to approve the June 29, 2023 Commission meeting minutes. All present voted aye by voice vote. The motion carried.

Karla Engle, Office of Legal Counsel, presented for Commission consideration amendments to Administrative Rules of South Dakota (ARSD) 70:01:02:00 – Interstate Highways speed zone rule and ARSD 70:01:02:27 – Fall River County speed zone rule.

Engle explained the rule adoption process that had been followed to date for the amendments to the rules. She discussed the purpose and effect of the rule changes. Engle reported that no written comments on the rule changes had been timely received.

Engle asked the Commission to edit subsection 1 in the proposed rule for ARSD 70:03:01: to read "sixty-five" instead of 65.

Karim asked for public testimony on the proposed rule amendments. No members of the public offered testimony in support of or in opposition to the rule changes.

A MOTION WAS MADE by Rosenboom and seconded by Zander to approve the amendments and make the further edit to ARSD 70:01:02:00 – Interstate Highways speed zone rule as recommended by Engle. All present voted aye by voice vote. The motion carried.

RESOLUTION #2023 – 7.1 was adopted.

Engle requested the Commission set a hearing date of August 24, 2023, to consider amendments to ARSD 70:01:02:49 Meade County Speed Zone Rule, 70:01:02:62 Union County Speed Zone Rule, and 70:06:03:02 Audits.

A MOTION WAS MADE by Roby and seconded by Simons to set the administrative hearing date for August 24, 2023. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2023 – 7.2 was adopted.

Karim opened the floor to public input.

No members of the public addressed the Commission nor offered input.

Secretary Joel Jundt presented the following items in his Secretary's Report to the Commission:

- Federal Funding: The Infrastructure Investment and Jobs Act (IIJA)/ Bi-partisan Infrastructure Law (BIL) will expire in 2026. The annual appropriation bill that is needed to fund this legislation will expire September 30, 2023. Although progress is being made in Congress, it is expected that a continual resolution will be passed again this year to fund the federal government.
- State Legislation: The Department of Transportation (the "Department") is in the early stages of looking to see if any legislation will be proposed by the ageny in the 2024 Legislative session.
- Reminder that the September Commission meeting will be in Sioux Falls on September 26 & 27. The Department is putting together a tour for Wednesday morning that may include 41<sup>st</sup> Street, Benson Road, and Veteran's Parkway construction projects as well as a tour of Cemcast pipe manufacturer. Also being considered is the I-90 paving project near Humboldt and specific locations near the construction projects to view the development and transportation growth of the city.

Craig Smith, Director of Operations, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in June contain an increase of \$1,405,090.62. Over the past 12 months, the overall contract increase is 2.67%.
