Vice-chairman Rolf Johnson called the meeting of the South Dakota Aeronautics Commission (the “Commission”) to order at 2:03 p.m. CDT. Roll call was taken. A quorum was determined.

Vice-chairman Johnson passed the gavel to Chairman Bob Huggins at 2:04 p.m. CDT.

Huggins opened the floor to the Commission to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) Chapter 3 – 23.

Karla Engle, Office of Legal Counsel, acknowledged the Board’s receipt of four annual disclosures submitted by Rolf Johnson, Court Ecklund, David Howard, and Dustin Coleman. The disclosures are attached to these minutes as **ATTACHMENT A - D**. The disclosures will be filed as required by law.

No other members of the Commission disclosed a conflict or requested a waiver.

Huggins left the meeting at 2:07 CDT.

Johnson asked for a motion to approve the Commission meeting minutes from June 18, 2026.

A MOTION WAS MADE by Venner and seconded by Howard to approve the meeting minutes from June 18, 2026.

Huggins rejoined the meeting at 2:09 p.m. CDT.

Commissioner Dustin Coleman listed four edits to the minutes.

1. Nick Wendell's spelling of his name was different in the minutes. He asked that the correct spelling be used throughout.
2. On page 2, the word "collector" was spelt wrong regarding the term *collector roads*.
3. The Chamberlain Airport Improvement Program (AIP) grant was missing a number for the state match and should read \$17,299 instead of \$7299.
4. The Winner AIP grant project had numbers that didn't add up to the number listed. Department of Transportation (the "Department") staff were asked to confirm the total amount of the grant and make the correction in the minutes.

No other commissioners had comments or corrections.

A SUBSTITUTE MOTION WAS MADE by Venner and seconded by Howard to approve the meeting minutes from June 18, 2026 with the edits noted above. All present voted aye by roll call vote. The motion carried.

Johnson returned the gavel to Huggins at 2:15 p.m. CT

Huggins requested the Commission submit comments on the Federal Aviation Administration (FAA) Aeronautical Study 2026 – WTE – 2099 – OE. He presented draft comments for Commission consideration as Attachment #3 to the Commission's meeting packet.

A MOTION WAS MADE by Johnson and seconded by Coleman to authorize Chairman Bob Huggins to submit the draft comments on the FAA Aeronautical Study 2026 – WTE – 2099 – OE on behalf of the Commission. All present voted aye by roll call vote. The motion carried.

Huggins opened the floor to public comment.

No members of the public addressed the Commission or offered input.

Karla Engle, Office of Legal Counsel, addressed the Commission. She explained that a 2025 law requires the Commission to annually acknowledge review of materials provided by the Attorney General concerning open meetings laws. Engle pointed out that the updated 2026 Open Meeting brochure authored by the Attorney General had been provided to the Commission as Attachment #4 for the Commission's review.

All present acknowledged reviewing these open meeting materials by roll call.

Secretary Joel Jundt presented his Secretary's Report. He shared with the Commission the FAA response to the comment the Commission made regarding FAA Aeronautical Study 2026-WTE-651-OE and what future action could be taken.

It was decided that the Department will notify the airports nearest the study of the FAA response to the Commission's comment and provide a copy of the FAA response to those airports. Doing so will allow these airports to determine if they want to take further action.

Nancy Hiller, Office of Air, Rail, & Transit, presented for the Commission's consideration the following state share funding increases on AIP grant projects:

Cheyenne Eagle Butte Municipal Airport AIP# 3-46-0068-17-2022

Construction: Existing Runway 13 Taxiway Connector Lighting, Construct Runway 31 Taxiway Turnaround Lighting (475'), Independent Fee Estimate, Purchase of Wetland Credits (approximately 1.34 acres), Electrical Service Revisions, Precision Approach Path Indicators, Flight Check

The federal grant amendment was approved to purchase additional wetland credits to mitigate some wetlands that were disturbed by the project.

Phase 2: Reconstruct and Widen of Runway 13/31 (Construction Engineering and Oversight), Shift and Reconfigure Existing Runway 13 Taxiway Connector, Construct Runway 31 Taxiway Turnaround (475')

The federal grant amendment was approved to cover two contract amendments to perform additional engineering services. The Federal Aviation Administration (FAA) required new aerial photography to be collected and processed for the first amendment. The Cheyenne River Sioux Tribe Cultural Preservation Office required additional monitoring for all earthwork and not just the top 12 inches listed in the proposal for the second amendment.

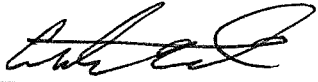

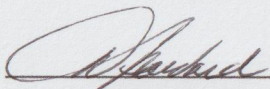

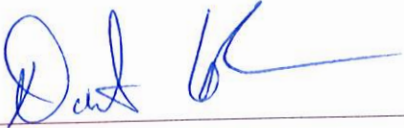
