Chairman Lynn Jensen called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CST. A roll call was taken and a quorum was present.

Jensen opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3-23.

Karla Engle, Office of Legal Counsel, presented to the Commission a waiver request for Commissioner Ronald Rosenboom related to his employment at West River Foundation. West River Foundation owns land near Exit 32 on I-90. Various contractors and subcontractors occasionally request to use this land for purposes of storing materials and equipment during construction projects and West River

Foundation often grants these requests and receives no compensation for these land uses. The requests are received after the Commission has made a determination on the bid awards, so there's no opportunity for recusal prior to Commission action. A copy of the waiver is included with these minutes as **ATTACHMENT A**.

A MOTION WAS MADE by Roby and seconded by Vehle that the matters disclosed in the written waiver request by Commissioner Rosenboom are fair, reasonable, and not contrary to public interest. All present voted aye by roll call vote except Rosenboom, who abstained. The motion carried.

Jensen asked for any other potential conflicts of interest. No other members of the Commission disclosed a conflict or requested a waiver.

Jensen asked for a motion to approve the April 25, 2024 Commission meeting minutes.

A MOTION WAS MADE by Roby and seconded by Rosenboom to approve the April 25, 2024 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Jensen asked for a motion to approve the May 9, 2024 Commission meeting minutes.

A MOTION WAS MADE by Vehle and seconded by Simons to approve the May 9, 2024 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Karla Engle, Office of Legal Counsel, presented for Commission consideration amendments to Administrative Rules of South Dakota (ARSD) 70:01:02:02 – Pennington County Speed Zone Rule; 70:01:02:06 – Brookings County Speed Zone Rule; 70:01:02:15 – Butte County Speed Zone Rule; 70:01:02:21 – Custer County Speed Zone Rule; 70:01:02:49 – Meade County Speed Zone Rule; and 70:01:02:53 – Perkins County Speed Zone Rule.

Engle explained the rule adoption process that had been followed to date for the amendments to the rules. She discussed the purpose and effect of the rule changes. Engle reported that no written comments on the rule changes had been timely received.

Jensen asked for public testimony on the proposed rule amendments. No members of the public offered testimony in support of or in opposition to the rule changes.

Commissioner Mike Vehle suggested the Department of Transportation (the "Department") consider using social media platforms along with the current newspaper advertisements and public website postings when advertising rule changes.

A MOTION WAS MADE by Roby and seconded by Frick to approve the proposed amendments to ARSD 70:01:02:02 – Pennington County Speed Zone Rule; 70:01:02:06 – Brookings County Speed Zone Rule; 70:01:02:15 – Butte County Speed Zone Rule; 70:01:02:21 – Custer County Speed Zone Rule; 70:01:02:49 – Meade County Speed Zone Rule; and 70:01:02:53 – Perkins County Speed Zone Rule. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2024 – 5.1 was adopted.

Jensen opened the floor to public input.

Frank Kloucek of Scotland, South Dakota addressed the Commission with the following items:

- He shared that the resurfacing project in the City of Mitchell has poor and unsafe signing being used. He requested that the signage be updated to be more visible.
- He shared his concerns with the new four-way stop at SD37/SD46 and suggested using flashing lights in advance of the stop signs.
- He shared his concerns with the reconstruction project of Highway 46 through Wagner, SD. He noted that there have been no deaths in Wagner with the current 4 lane system and is not sure why the Department is making the changes to 3 lanes and 5 lanes.

No other members of the public addressed the Commission nor offered input.

Secretary Jundt presented to the Commission his Secretary's Report. He started by introducing the newly appointed commissioner, Rick Vallery, and asked Commissioner Vallery to share some history about himself. Next, Jundt noted that a bridge dedicated to the three Herr family fallen heroes is being moved by request from the family. The new bridge location is closer to the family. No formal action is required by the Commission. He also explained the House sub-committee THUD has set hearing on June 27, 2024 to receive input on the next federal appropriation bill. Finally, Jundt shared that the Hall of Honor applications are due May 24.

Jundt presented for Commission consideration the need to replace Kathy Zander on Transportation Hall of Honor Committee. Chairman Jensen volunteered and passed the gavel to Vice-chairman Roby.

A MOTION WAS MADE by Vehle and seconded by Vallery to approve the nomination of Lynn Jensen to replace Kathy Zander as the Commission representative on the Transportation Hall of Honor Committee. All present voted age by roll call vote except Jensen who recused himself. The motion carried.

Craig Smith, Division Director of Operations, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in April contain a decrease of \$127,938.12. Over the past 12 months, the overall contract increase is 2.24%.

Explanation of Change on CCO No. 1: This decrease is the result of SDDOT adjusting contract quantities of durable pavement markings from 6" to 4". The contract was let anticipating a change in standards for interstate markings to be required to be 6", but the standards did not change.

Craig Smith gave a summary of winter operations for 2023/2024 in comparison to the previous year. He shared that the cost was less than half of last year, at around \$19 million vs. \$42 million. He noted there was only one closing of the interstate system on Christmas day, and there were less vehicle accidents involving plow trucks.

He also noted that the Department has worked with local counties and tribes to upgrade the SD511 system. Moving forward, closures on a majority of the counties and tribes' roadways will also be available on SD511.

Commissioner Don Roby left the meeting at 9:56 a.m.
