## OTHERS PRESENT

VIA CONFERENCE CALL:

Chairman Lynn Jensen called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CST. A roll call was taken and a quorum was present.

Jensen opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3-23.

No members of the Commission disclosed a conflict or requested a waiver.

Jensen asked for a motion to approve the June 13, 2024 Commission meeting minutes.
A MOTION WAS MADE by Roby and seconded by Vehle to approve the June 13, 2024 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Jensen opened the floor to public input. The following people addressed the Commission:

- Frank Kloucek of Scotland shared his concerns for the speed zone at the intersection of US18 and US81 after a recent fatal accident at that intersection. He suggested stronger lighting at the intersection of SD37 and SD46. He also expressed concerns about changing from a five lane to a three lane highway through Wagner.
- Jeff Stewart of Wagner shared his concerns about the T intersection of SD281 and SD46, stating the stop-ahead warning sign is too close to the stop sign and does not allow for enough time for drivers to react. He also stated the signage in advance of the intersection of SD 46 and US 281 is concerning to him. He said he shares concerns about the intersection of US 18 and US81. He also shared a safety concern for the lack of a turn lane at the bottom of the hill to make turns from SD37 to SD 46. He believes truck speeds make it unsafe. Lastly, he also stated he has safety concerns with the lane change on the highway through Wagner.
- Abby Streyle who works at the gas station at Meridian Corner shared her safety concern for the US18/US81 intersection, asking for a 4 way stop sign or a reduction in speed.
- Roland Svartoien of Wagner shared his concerns about the intersection of US18/US81 asking for action on a speed limit reduction, turn lane, or four-way stop to improve safety.

Jensen asked for a motion for the Commission to enter into executive session.

A MOTION WAS MADE by Simons and seconded by Frick to enter into executive session pursuant to SDCL 1-25-2(3) for the purpose of consulting with legal counsel and reviewing communications from legal counsel about proposed or pending litigation or contractual matters. All present voted aye by roll call vote. The motion carried.

Executive session began at 9:12 a.m.

Executive session ended at 10:11 a.m. CT.

Secretary Joel Jundt presented the following items to the Commission in his Secretary's Report:

- Massive flooding in southeast portion of the state by the Vermillion, James, and Big Sioux Rivers. The water flooded I-29 requiring it to close and detour travelers on to SD48 into lowa and Minnesota until that road flooded which also required closure. The Department of Transportation (the "Department") worked closely with North Sioux City and built a levee. I-29
did not sustain any damage, but other bridges and roads sustained major damage and will require repairs. Craig Smith, Division Director of Operations, shared with the Commission more details about the action taken by Department maintenance staff. At one point $25+$ locations of road were either closed or flagged due to water over the road. SD48 lost surfacing and the James River Bridge sustained damage at the approach; both areas will require the Department to bring in a contractor due to the extensive repairs required. Both Jundt and Smith shared their admiration for the work done by the Department staff.
- A bridge on US12 near Mobridge over the Missouri River sustained a bridge hit. Emergency state construction funds will be used for repairs.
- The bridge scheduled to be dedicated to Army 1LT Josef L. Thorne on November 11, 2024 has been changed to a different bridge on SD46 over the Vermillion River because after inspection, the original planned bridge is going to be replaced by a box culvert.
- There is a ribbon cutting scheduled on July 2 in Sioux Falls for the Diverging Diamond Intersection (DDI) at $41^{\text {st }}$ Street. This is the $2^{\text {nd }}$ DDI in the state.
- The Department was awarded a RAISE grant for US18 between Martin and Mission for \$25 million.

Jundt presented for Commission consideration a request for a State Infrastructure Banks ("SIB") loan from Lincoln County to install a new interchange at $1-29$ and $85^{\text {th }}$ Street. The project was given a $\$ 30$ million earmark 10 years ago. In 2014, the Commission approved the project in the STIP. The Department entered into a Memorandum of Understanding with Lincoln County that contemplated a SIB loan to partially finance the project. Now, Lincoln County is requesting a SIB Ioan for $\$ 15$ million amortized over 10 years at $1.5 \%$ interest.

Jim Schmidt, a Lincoln County Commissioner addressed the Commission to present the loan request. Toby Brown of the Lincoln County Planning Department described for the Commission the plan for using a TIF to repay the loan. Sheri Lund, Lincoln County Auditor, answered Commission questions. Sioux Falls Mayor, Paul TenHaken, addressed the Commission to show support from the City of Sioux Falls as a collaborating entity on this project. Mark Cotter, Director of Public Works for the City of Sioux Falls, also addressed the Commission to express the support of the city and answer questions by the Commission. Lastly, Mike Poppes, a Lincoln County Commissioner, addressed the Commission to confirm Lincoln County's position and plan for the SIB loan request.

A MOTION WAS MADE by Frick and seconded by Karim to approve the request for a SIB loan of $\$ 15$ million to Lincoln County to be repaid within 10 years after the interchange project completion. Said loan will be amortized over 10 years with interest at a rate of $1.5 \%$ compounded annually. The loan is further contingent on Lincoln County approving the proposed TIF for repayment of the loan and Lincoln County further pledging its Surface Transportation Block Grant Program (STBGP) annual allocation toward repayment of the loan. All present voted aye by roll call vote. The motion carried.

Craig Smith, Division Director of Operations, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in May contain an increase of $\$ 2,269,987.13$. Over the past 12 months, the overall contract increase is $2.06 \%$.

Commissioner Roby stepped away from the meeting from 12:28-12:29 p.m.
Commissioner Larry Nelson left the meeting at 12:45 p.m.
Mike Behm, Division Director of Planning \& Engineering, presented for Commission approval the release of the tentative 2025-2028 Statewide Transportation Improvement Program (STIP). He shared a video of the new virtual meeting room that will be used this year for public meetings. He noted that with public attendance numbers being very low the last few years, the Department has chosen to do two live virtual meetings for the public to attend as well as the virtual meeting room that can be accessed at any time via the Department's webpage.

A MOTION WAS MADE by Roby and seconded by Karim to approve the release of the 2025 - 2028 STIP. All present voted aye by roll call vote. The motion carried.

Secretary Jundt asked the Commission for an informational item for the July meeting. Commissioner Frick asked about the safety procedures but asked it to be presented at the August meeting as he will not be able to attend the July meeting. Jundt said he'd work with Chairman Jensen to choose a topic.

With no further business to come before the Commission, Chairman Jensen declared the meeting adjourned at 12:50 p.m. CT.
