Chairman Larry Nelson called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CDT.

A roll call was taken, and a quorum was determined.

Nelson opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3 - 23.

No conflicts of interest were disclosed, and no waivers were requested.

Nelson asked for a motion to approve the April 15, 2021 Commission meeting minutes.

A MOTION WAS MADE by Karim and seconded by Zander to approve the April 15, 2021 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Commissioner Vehle joined the meeting at 9:02 a.m.

Karla Engle, Office of Legal Counsel, requested the Commission to set a hearing date of May 27, 2021 to consider amendments to Administrative Rules of South Dakota (ARSD) 70:01:02:07 – Yankton County speed zone rule and ARSD 70:13:01:10 – project requirements. She explained that the request for adoption of ARSD 70:01:03:38 – parking prohibited on a portion of State Trunk Highway 48 in Union County was withdrawn by the Office of Operations Support.

A MOTION WAS MADE by Vehle and seconded by Cull to set the administrative hearing date for May 27, 2021 for consideration of ARSD 70:01:02:07 – Yankton County speed zone rule and ARSD 70:13:01:10 – project requirements. All present voted age by roll call vote. The motion carried.

# RESOLUTION #2021 – 4.1 was adopted.

Commissioner Bruce Cull asked that the speed zone in Yankton County be amended to eliminate an outdated reference to the upper and lower deck of the bridge over the Missouri River. Engle indicated this clean-up item would be addressed before the hearing.

The Commission discussed the number of recommendations presented. The original plan was for a total of six (6) bridges named each year. It was increased this year due to the number of nominations and the number of WWII vets nominated.

Audrey Rickets of the Department of Veteran Affairs answered questions from the Commission.

A MOTION WAS MADE by Rosenboom and seconded by Zander to approve the naming of the bridges as requested. All present voted aye by roll call vote. The motion carried.

3. Secretary Kevin Robling of the Department of Game, Fish & Parks (GF&P) presented a funding request for GF&P. Robling shared with the Commission the need for additional funding from the Department to help cover the projected shortfall in the next five (5) years.

A MOTION WAS MADE by Cull and seconded by Vehle to authorize the Secretary of Transportation to execute an agreement with GF&P allocating \$2.8 million for FY2022 and a memorandum of understanding (MOU) with GF&P to allow for the allocation of up to \$2.8 million in funding for the following four (4) years, subject to the following conditions:

- All funding will be used only for construction and improvement of collector roads,
- GF&P Commission will determine what collector roads qualify for expenditure,
- GF&P will submit a yearly report of highway performance measures, and
- No allocation of funding beyond 2022 will be made without additional review and approval made by the Transportation Commission

All present voted aye by roll call vote. The motion carried.

Additional base course material was used to strengthen unstable areas. Additional asphalt concrete was used to repair damage to the asphalt shoulder caused be interstate traffic during construction.

Explanation of Change on CCO No. 14: This increase is the result of the Department adjusting the contract quantities of undercut, salvage & stockpile asphalt mix and granular base material, asphalt binder, and asphalt concrete. The increase in the undercut item was the result of the Department ordering additional undercut in areas of unstable subgrade. The amount of in place surfacing material salvaged was significantly more than estimated in the plans. The additional asphalt binder and asphalt concrete was the result of additional crossovers placed during construction to allow for more access to business and the Contractor access to more phases of the project for faster construction.

<u>Explanation of Change on CCO No. 16:</u> This increase is the result the Department making and incentive payment for pavement smoothness. The incentive payment was made in accordance with the contract.

Explanation of Change on CCO No. 1: This decrease is the result of the Department adjusting and eliminating numerous items of work. The adjustments and eliminations match the quantity and items of work completed by the Contractor through normal project variations. Additionally, the high-water overtopping of the roadway resulted in the Department closing the roadway ahead of construction which resulted in a significant decrease in traffic control during construction.

During construction and removal of delaminated concrete, the Department determined additional removal was necessary to repair the structure which resulted in additional concrete overlay volume.

Explanation of Change on CCO No. 8: This decrease is the result of the Department eliminating asphalt for prime from the work due to late season paving of the shoulders, the Department adjusting the contract quantities of several erosion control items due to the abnormally dry conditions encountered during construction, and numerous minor quantity adjustments to various contract items through normal project variations. Additionally, this CCO included numerous small price adjustments for materials that failed to meet the contract requirements but were deemed to be in reasonably close conformance and allowed to remain in place at a reduced price.

Explanation of Change on CCO No. 21: This decrease is the result of the Department adjusting the contract quantities of asphalt for prime and water for embankment. The adjustments were made to match the quantities used during construction. Asphalt for prime was not used on a portion of the project due to late season work. The amount of water for embankment used to construct the grade was significantly less than estimated in the plans.

Mike Behm, Division Director of Planning & Engineering, presented to the Commission four additional projects proposed for 2021 Local Federal Bridge funding on behalf of GF&P.

A MOTION WAS MADE by Zander and seconded by Vehle to approve project #1 – 4 for GF&P bridges as outlined in attachment #8 and add the projects to the STIP by revision. All present voted aye by roll call vote. The motion carried.
