Chairman Karim called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CDT. A roll call was taken and a quorum was present.

Karim opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3 - 23.

No members of the Commission disclosed a conflict or requested a waiver.

Secretary Joel Jundt explained that the next commissioners next in line for the vice-chair position would be Commissioners Simons and Frick. Due to their recent appointments to the Commission, they each indicated their desire to delay their service as vice-chair. Jundt recommended that Don Roby, who would be the next in line to serve as vice-chair, be nominated to the position in order to give Commissioners Simons and Frick more experience on the Commission before taking the position.

A MOTION WAS MADE by Zander and seconded by Vehle to elect Lynn Jensen as the Chair effective at the conclusion of the meeting of the Commission. All present voted age by roll call vote. The motion carried.

A MOTION WAS MADE by Jensen and seconded by Rosenboom to elect Don Roby as the Vice-chair effective at the conclusion of the meeting of the Commission. All present voted aye by roll call vote. The motion carried.

Karim opened the floor to public input.

No members of the public addressed the Commission nor offered input.

\*\*\*

Secretary Joel Jundt presented the following items in his Secretary's Report to the Commission:

- The Federal appropriations bill has still not been signed. Another continuing resolution was signed and is set to expire on March 1, 2024.
- The Department of Transportation (the "Department") was awarded a federal INFRA (Infrastructure for Rebuilding America) Discretionary Grant for \$16.8 million for the project on SD73 from Kadoka south, including the SD248 Service Road.
- The Department has joined 20 other states in a lawsuit against the United States Department of Transportation, the Federal Highway Administration (FHWA) and various federal officials relating to a new rule requiring state DOTs and Metropolitan Planning Organizations (MPOs) to set declining greenhouse gas (specifically tailpipe CO2) emission targets in connection with transportation planning Karla Engle, Office of Legal Counsel, provided information about the legal filings and procedural status of the case.
- The Secretary and Department directors made a presentation to the Transportation Committees for both the South Dakota House of Representative and South Dakota Senate. The presentation focused on the current status of the state's bridges and pavements.
- An educational presentation was offered to the legislators on automated vehicles (AV) by the Connected and AV Advisory Group. HB1095 was introduced this session and has passed the House Commerce and Energy Committee with a 10-3 vote and will be heard on the House floor on the day of the Commission meeting. In the bill, the Commission would be given authority to promulgate administrative rules.
- There was a bridge hit on I-90 at mile marker 380.93 which is just west of Sioux Falls. There was girder damage. The Department will let the project as an emergency and use construction funds to fund the repairs.

• With the bridge hits, there have been questions regarding how much of the claims are being reimbursed. Jundt shared that in projects over \$100,000, 98.7% of the project costs are being recovered via invoices to the insurance companies.

Craig Smith, Division Director of Operations, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in December contain an increase of \$844,397.92. Over the past 12 months, the overall contract increase is 2.52%.
