Chairman Roby called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CT. A roll call was taken and a quorum was present.

Roby opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3-23.

No members of the Commission disclosed a conflict or requested a waiver.

Roby asked for a motion to approve the June 12, 2025 Commission meeting minutes.

A MOTION WAS MADE by Jensen and seconded by Simons to approve the June 12, 2025 Commission meeting minutes. All present voted aye by voice vote. The motion carried.

Karla Engle, Office of Legal Counsel, announced a public hearing on the Commission's consideration of proposed amendments to Administrative Rules of South Dakota (ARSD) 70:01:02:03 – Brown County speed zone rule.

Engle explained the rule adoption process that had been followed to date for the amendments to the rule. She discussed the purpose and effect of the rule changes. Engle reported that the rule changes were supported by the South Dakota Highway Patrol, the Brown County Sheriff, and the Aberdeen Police Department. Engle also reported that no written comments on the rule changes had been timely received. Engle also reported that Legislative Research Council had no changes to the proposed rules.

Roby asked for public testimony in favor of or opposed to the proposed rule amendments. No members of the public offered testimony in support of or in opposition to the rule changes.

Jon Suomala, statewide traffic engineer for the Department of Transportation (the "Department"), explained changes in the methodology for setting speed limits, which emphasizes the importance of other factors in addition to the 85th percentile speed analysis. Secretary Jundt explained that the methodology changes were the result of a national research study. Commissioner Simons added that this segment of highway experiences high levels of truck traffic and a high level of truck turning movements due to the presence of several grain elevators.

A MOTION WAS MADE by Simons and seconded by Frick to approve the proposed amendments to ARSD 70:01:02:03 – Brown County speed zone rules. All present voted age by voice vote. The motion carried.

RESOLUTION #2025 – 6.1 was adopted.

Engle then requested the Commission set a hearing date of July 24, 2025 to consider amendments to ARSD 70:01:02:44 – Lincoln County speed zone rules.

A MOTION WAS MADE by Jensen and seconded by Nelson to set the administrative hearing date of July 24, 2025, for consideration of amendments to ARSD 70:01:02:44 – Lincoln County speed zone rules. All present voted aye by voice vote. The motion carried.

RESOLUTION #2025 – 6.2 was adopted.

Roby opened the floor to public input.

No members of the public addressed the Commission or offered any input.

Secretary Joel Jundt presented the following items to the Commission in his Secretary's Report:

• Federal Budget Reconciliation: As previously reported, the House passed its budget reconciliation bill on May 22, 2025. The Senate has yet to pass its bill. The President's goal is to have this legislation passed before the July 4th break. To the Department's knowledge, the Senate's draft bill does not include a charge for electric or hybrid vehicles at this time. Since the House and Senate bills differ, the end result is the subject of continued negotiations.

- Federal Reauthorization: Both the House Transportation & Infrastructure Committee and the Senate Environment and Public Works Committee provided portals for their members to submit suggestions for possible legislative changes for the next surface transportation bill. The committees are now sorting through all the portal filing. The Department provided input, with the main goal of maintaining the current formula funding, reducing the number of burdensome federal regulations, and granting states more flexibility with the federal funds received.
- Federal Annual Appropriations: The House has begun marking up appropriations bills and so far, the votes have been primarily along party lines. Transportation-HUD (THUD) Subcommittee markup is scheduled for July 14, with full committee markup of the THUD bill scheduled for July 17. The Senate has not yet scheduled any appropriations markups. Similar to past years and with all the issues going in DC and overseas, the Department is assuming Congress will again pass a continuing resolution (CR) for the new Federal fiscal Year (2026) appropriations and this CR would likely provide federal funding into December 2025.
- State: As approved by the Commission as an ongoing annual allocation, the Department transferred state funds to the counties and to the Class 1 cities (population of 5000 or more) based on their annual Surface Transportation Block Grant Program (STBGP) funding allocations. The total amount provided to the counties and Class 1 cities for this year is \$39.577 million. Of that amount, \$10.951 million was held back to offset loan balances or build balances for pending projects, leaving \$28.117 million of funds transferred to these local governments last week. In addition, \$508,000 was provided to counties opting into the pavement marking program

Craig Smith, Division Director of Operations, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in completed in May contain an increase of \$1,260,096.50. Over the past 12 months, the overall contract increase is 1.68%.

The plans rate and quantity of hydrated lime was calculated at 1.0% but was approved for mix design at 0.5% which reduced the hydrated lime quantities drastically.

John Keyes, Program Manager for the Office of Right of Way (ROW), presented the following items for Commission consideration.

1. Request Transportation Commission approval to transfer by resolution to the City of Rapid City, Pennington County, South Dakota, the following property acquired for SDDOT right of way: Segment 1 - 4.6 miles of Campbell Street and East North Street from 500 feet south of Minnesota Street north to I-90 including the St. Joseph Street ramps, except the structure located over the railroad located approximately 0.3 mile south of St. Patrick Street

Segment 2 - 2.1 miles of Eglin Street and Edwards Street from North Street east to US16B.

Segment 3 - East St. Patrick Street from Campbell Street east to SD44.

This resolution will meet requirements of Financial and Road Transfer Agreement #612978 between SDDOT and the City of Rapid City. The property described in ROW Item #1 in Attachment #5 of the Commission meeting packet would be transferred to the City of Rapid City and the City of Rapid City would accept ownership, jurisdiction, operational and maintenance responsibilities of the property. Rapid City Region and Area SDDOT recommend the transfer.

A MOTION WAS MADE by Vehle and seconded by Rosenboom to approve the transfer to the City of Rapid City shown as ROW Item #1 in Attachment #5. All present voted aye by voice vote. The motion carried.

RESOLUTION 2025 – 6.3 was adopted.

2. Request Transportation Commission approval to transfer by resolution to the City of Watertown, Codington County, South Dakota, the following property acquired for SDDOT right of way: Lot H1 in Govt. Lot 4 of Section 25, Township 117 North, Range 54 West of the 5th P.M., Codington County, South Dakota.

This resolution will meet requirements of Letting, Financial, Maintenance, Encroachment and Transfer Agreement #713874 between SDDOT and the City of Watertown. The property described above would be transferred to the City of Watertown and the City of Watertown would accept ownership, jurisdiction, operational and maintenance responsibilities of the property.
